Property Tax Software

Mayor asked the clerk if she can explain what this software is all about, the clerk had explained that this software will keep better records. It will take from the beginning to the end about 2 months and with the software about 2 weeks.

Commissioner Pierce asked if this is a one-time fee. The clerk responded yes.

Commissioner Martin asked if the software was going to have upgrades. The clerk explained no you will not have to. Mayor Watt asked if the Commission had any more questions with none. A motion was made by Commissioner Pierce seconded by

Commissioner Higginbotham to purchase the property tax software for the amount of \$1495.00. A roll call was taken. Roll call: Voting yes: C. Varner, C. Higginbotham,

Park Benches & Flagpoles (City park Project)

Mayor Watt said that the flagpoles that the state was going to give the city had been stolen, so now the city would have to purchase the poles. Mayor Watt said he had spoke with Ron East and he suggests that the city should get (1) 25ft and (2) 20ft.

He had also spoke with Mike Murphy on this issue as well as park benches Mike is suppose to check on prices for the benches. Mayor Watt would like a motion to let Mike Murphy go ahead with the project and just charge the city. With no more discussion motion was made by Commissioner Martin seconded by Commissioner Pierce to allow Mike Murphy to continue with the project and just bill the city for the charges. A roll call

was taken: Roll call: Voting yes: C. Varner, C. Higginbotham, Mayor Watt, C. Martin and C. Pierce. Voting no: none

Mayor Watt said that Ron East also had given a price on the city flag for (1) one the cost is \$198.00 but if the city were to buy (3) three the cost is \$120.00 each. Mayor Watt said he personally thinks the city should get (3) three. The Commission agrees. A motion was made by Commissioner Pierce seconded by Commissioner Varner to purchase (3) three flags. With no more discussion. A roll call was taken: Roll call: Voting yes: C. Varner, C. Higginbotham, Mayor Watt, C. Martin and C. Pierce. Voting no: none

Lion's Club Donation

Mayor Watt said the city does not even know how much the Lion's Club is wanting to donate and really until we know this we really can not do much until we know something. Commissioner Higginbotham said he would find this information out. Sherry Higginbotham said that the Beautification would like to put a sign going out of town Welcoming into Smiths Grove. Mayor Watt said he has no problem with that, but until we get more information on how much they are going to donate we need to put this off until next meeting.

Taser Gun

Mayor Watt said the drug money that Chief Vance had received the City had opened a Drug Fund the dollar amount was \$1264.00. Chief Vance could explain about the Taser Gun. Chief Vance said that in a study conducted by the LAPD the Taser was shown to have the lowest injury rate of any force option. This is both suspect and officer. The Phoenix PD reports 67% decline in suspect injuries. Chief Vance had demonstrated with the use of the Taser gun used on Officers. He said he would be going to have the same thing done as well. All this does is puts an electric shock to the person. The Mayor and Commission feel that this would be good for Chief Vance to go ahead and get this Taser Gun. With no more discussion. Commissioner Higginbotham makes a motion seconded by Commissioner Varner to make the purchase from the Police Drug Fund to get a Taser Gun. A roll call was taken: Roll call: Voting yes: C. Varner, C. Higginbotham, Mayor Watt, C. Martin and C. Pierce. Voting no: none

Mayor Watt said that if no one has any more questions this meeting is adjourned. Mayor Watt adjourned the meeting approximately 8:05 p.m.
