Minutes of the Meeting of the Board of Trustees, Tuesday, December 2, 1958.

The Board met at 7 P.M. in the Director's Room of the Smiths Grove Branch of the American National Bank with all members present. The following business was transacted:

The minutes of the meeting of the Board of Trustees on November 4, 1958 were read and approved.

1. Police report - No report other than the collection of occupational taxes.
2. Equipment for the second fire truck - Trustee Thomas reported nothing more has been done. Mr. Lanis Martin, Chairman for the Lions Club committee, has been busy in tobacco, etc. Trustee Denton reported that he talked to Mr. Martin and Mr. Martin was to contact Joe Davenport to see if his work shop could be used for working on the truck.
3. No report on Jewel T.
4. Mrs. Anderson reported she had contacted Judge Milliken, Sr. in reference to fencing the cemetery. He advised her that if Mr. Lowe had put up his half of the fence and sent a written notice a month in advance that we would be liable for the other half. Since Mr. Lowe has not given written notice, it was decided to hold this matter in abeyance until the Board was asked to rule on it. She reported that Judge Milliken further advised her that if the Board felt it essential to use the cemetery funds for such work, they could legally do so.
5. The roof of the fire station was repaired under the supervision of Mr. Cassady for a total cost of \$32.24.
6. A bill for \$46.53 was presented for wiring the fire sirens.
7. Chairman Smith reported he had been unable to contact the fire marshall.
8. Under new business, Chairman Smith reported that when the streets were repaired last Spring, they failed to do some grading and filling in front of the George Compton residence and next to Homer Doyle. Trustee Thomas made a motion seconded by Trustee Denton that Chairman Smith contact Mr. Edwards regarding this work. There were no dissenting votes.
9. Chairman Smith presented a letter from G. H. Parker, Manager of the Kentucky Inspection Bureau, recommending several improvements in the fire department if the city is to maintain its present eighth class fire insurance classification. Clerk was requested to write


