Minutes of the meeting of the Board of Trustees, February 2, 1954.

The Board met as usual at 7:00 PM, in the Director's Room of the Deposit Bank. After being called to order the following business was transacted:

1. Shobe-Mitchell lot contraversary: The clerk presented copy of letter which he had written to Mr. W. M. Shobe, and Mr. Shobe's reply. Since Mr. Shobe did not give any satisfaction in his letter Mrs. Stone was instructed to check with County Attorney Marshall Funk and find out if Mr. Shobe is entitled to eight or sixteen graves, according to way deed was written.
2. Upon a motion by Mrs. Stone, seconded by Mr. Denton, the tax rate for the coming tax year will remain at 75¢ per \$100.00 assessed valuation.

7. Outside Laundries will be required to pay an annual Occupation License Fee of \$100.00, ordinance to read as in draft of ordinance now in hands of Mrs. Stone.
8. Jewel Tea Company - Clerk is directed to write letter to Clerks at Cave City, Horse Cave and Park City and enquire as to what type of license they require them to pay and how much they charge.
9. Tax Equalization Board - The following men are reappointed to the Tax Equalization Board for the current Tax Year. Mr. Lowe will contact Mr. Smith and Mr. Marr relative to time they wish to get together to hear any protests as to why their tax should be lowered.

12. Upon a motion by Mrs. Crump, seconded by Mr. Tarter, the Clerk was instructed to pay the Bank \$600.00 plus interest on City note. There were no dissenting votes.

There being no further business to come before the Board the meeting was dismissed until its next regularly scheduled meeting, Tuesday, March 2, 1954.
