### 1. Minutes of the previous meeting

### 3. Treasurer's report

Having reviewed this report in advance of the meeting and with no additions or corrections to same, Comm. Belcher presented a motion to accept the report as printed, seconded by Comm. Lacy. Roll call and vote - Belcher yes, Gilley yes, Crisp yes, Lacy yes.

### 4. Resolution for intent to apply for solid waste management area designation - Warren Co.

The clerk explained that at the meeting she had attended 7/17/90 they explained to her that this was merely a resolution from the city stating their desire that Warren Co. handle the waste problems so that the city of Smiths Grove would not have to in the near future. Comm. Belcher wondered if by stating this resolution the Commission would have to be responsible for inspecting each residence in the city for proper disposal of waste. The clerk said, to her understanding, this would all be the counties responsibility. With no further discussion to be heard, Comm. Lacy

presented a motion to pass this resolution, seconded by Comm. Belcher. Roll call and vote - Belcher, yes, Gilley yes, Crisp yes, Lacy yes.

#### 5. Annual financial statement - Smiths Grove Cemetery

Ms. Jordan was not in attendance to answer any questions the commission might have. They reviewed the report and with no additions or corrections to be heard, Comm. Crisp presented a motion to accept the report as printed, seconded by Comm. Belcher. Roll call and vote - Belcher yes, Gilley yes, Crisp yes, Lacy yes.

#### 6. Annual financial statement - City of Smiths Grove

The commission reviewed this report and with no additions or corrections to same, Comm. Belcher presented a motion to accept the report as printed, seconded by Comm. Lacy. Roll call and vote - Belcher yes, Gilley yes, Crisp yes, Lacy yes.

#### 7. Other

Mayor Gilley explained it was again time to apply for ADF grants. He was of the opinion the city should apply for a grant to replace all of some of the sidewalks throughout the city since most of them were in a bad state of deterioration. All of

Belcher presented a motion the city apply for an ADF grant for the purpose of replacing the sidewalks throughout the city, seconded by Comm. Lacy. Roll call and vote - Belcher yes, Gilley yes, Lacy yes, Crisp yes.
