

The regular meeting of the Board of Trustees of the City of Smiths Grove was held on June 27, 7:30 p. m. at the county fire station, Main & Laurel Streets in Smiths Grove, Ky. Those present were Carolyn Harlin, Charles Cowles, and Leland Anderson.

Mrs. Harlin called the meeting to order. The minutes of the previous meeting were read and approved. The Clerk gave the treasurer's reports.

Committee reports were called for by Mrs. Harlin.

Cemetery: Mrs Harlin reported the annual bills of \$10.00 have been sent out.

Fire Dept: Mr. Wingfield reported that the fire truck needed to be driven at least twice a week. Arrangements for it to be driven were made.

Police: Mr. Cowles reported that the City needed a policeman. Mr. Cowles moved, Mr. Anderson seconded, that the Board hire Mr. Jesse Watt at a salary of \$250 per month and \$100 car expenses. The motion carried. Mrs. Harlin directed the clerk to have the police phone disconnected from David Dodds old apartment and have it transferred to Mr. Watt's home.

Water Dept: Mrs. Anderson reported things were going well. Mrs. Harlin read the water department financial report. The new water rates will go into effect the first of July.

Streets: Mrs. Harlin announced that Richardson would be paved from one end to the other. The letters to the street residents concerning the paving have been mailed. Mrs. Harlin read a letter from the Department of Transportation stating that Smiths Grove would receive approximately \$1,818.00 as a supplement to Municipal Aid for damaged streets. It will be available July 1.

The Clerk Announced that the Occupational License Notices have been mailed.

Mrs. Harlin read a letter concerning the Local Government Issues Conference. Mrs. Harlin moved, and Mr. Anderson seconded, that if Mr. Appling could attend, the City would pay the \$25.00 registration fee.

It was reported there had been some confusion over the loaning of water department equipment. Mr. Cowles moved, Mr. Anderson seconded, that no equipment from the water department be loaned to anyone except the fire department.

Mrs. Harlin reported the Kentucky Municipal League had developed their own low cost workman's comp insurance. But we must join with annual dues of \$100.00 in order to qualify. It was decided that Mrs. Harlin would check on the rates and see if it was feasible.

Mrs. Harlin handed out the zoning ordinance now in existence for the City.

A bill from the Park City Daily News for 199.44 was presented. This included much of the publishing of notices for Revenue Sharing and Community Developments Hearings. Mr. Cowles moved, Mr. Anderson Seconded, that we pay the bill. The motion carried.

Mrs. Harlin brought up the City's need for a good copuing machine. Sue Edwards explained some of the information that had already been obtained about different types of copiers. Mr. Cowles moved, Mrs Harlin seconded, that Mrs. Harlin and the clerk be authorized to buy a copier for the City. The Motion carried.

The meeting was adjourned.
