

City Commission meeting - Monday June 28, 1982 - City Hall 7: 00 pm

The meeting was called to order, in the absence of the Mayor, by acting Mayor Leland Anderson. He ask each of the Commissioners to attendance to review the Budget Amendment #82-3-220.7. Mr. Pearson addressed the City Clerk with several questions concerning the amendment. After a brief discussion, a motion to approve the amendment was presented by Mr. Anderson, seconded by Mr. Van Der Stelt. Roll call and vote - Pearson yes, Anderson yes, Van Der Stelt yes.

Mr. Anderson then presented the Fiscal year 1982-1983 budget for the commission's consideration. After examining the budget, a motion to approve the budget as written was presented by Mr. Van Der Stelt, seconded by Mr. Pearson. Roll call and vote – Pearson yes, Anderson yes, Van Der Stelt yes.

The Treasurer's report was presented, with no corrections or additions, a motion to accept it as written was presented by Mr. Anderson, seconded by Mr. Pearson. Roll call and vote- Anderson yes, Pearson yes, Van Der Stelt yes.

1. Louisville & Nashville Railroad resolution

A resolution to Louisville & Nashville Railroad Company, regarding the lease of the park for five (5) years at a rate of \$35.00 per year was presented. (Copy of lease and resolution attached). A motion to accept the resolution was made by Mr. Pearson, seconded by Mr. Anderson. Roll call and vote - Anderson yes, Pearson yes, Van Der Stelt yes.

2. Building permits

A building permit for Ms. Millie Boards was presented. After a brief discussion, a motion to issue the permit was made by Mr. Pearson, seconded by Mr. Anderson. Roll call and vote - Anderson yes, Pearson yes, Van Der Stelt yes.

A building permit for Mr. Gene Woods was presented. A motion to issue the permit was presented by Mr. Van Der Stelt, seconded by Mr. Pearson. Roll call and vote- Anderson yes, Pearson yes, Van Der Stelt yes.

3. Grain dryer noise

Mr. Anderson ask the commission if this action, or any decisions, could be carried over to the next meeting. Mr. Herbert Leopold addressed the meeting, stating that he was promised action by the Mayor at the May meeting, and he expects some kind of action to be made at this meeting. He was of the opinion if other business could be decided upon in the absence of the Mayor, so could his request. Any further delay is very unreasonable. He stated, since October 1982, he and his wife have been kept awake at least 35 nights due to the noise from the grain dryers. He read excerpts from the city commission meeting held November 27, 1972, -at which time he requested (1) the sound be muffled in some manner, -(2) the grain dryers not be used at night, in such a manner as they disturb he and his wife. He said former Mayor Wolff had written to the owners telling them he had surveyed the Mill and was in agreement with Mr. Leopold something should be done to curtail the noise. Mr. Pearson ask Mr. Leopold if the owners used the six feet of straw around the fans and shoots that was recommended by the Grand Jury, would this suffice. Mr. Leopold replied, no, more needs to be done. He felt the town owed him the courtesy of further action being taken now. The City Clerk addressed the commission, asking if it would help if she wrote a letter to the owners requesting them to abide by the Grand Jury recommendations, Mr. Leopold said this was a commission decision not the City Clerk, although he appreciated her efforts. With no further business to be presented a motion to adjourn was made by Mr. Anderson, seconded by Mr. Van Der Stelt.
