

City Commission meeting - May 22, 1989 - 7:00 p.m. - City Hall

PROPOSED USE HEARING, MUNICIPAL AID ROAD FUNDS

Mayor Gilley ask Comm. Belcher, in charge of the city streets, if he had surveyed the streets within the city that were in need of repair or resurfacing. He had. Comm. Belcher felt the only street that needed complete resurfacing was Witherspoon in its entirety. He also said that in his opinion where Lawson Street turns into Ridgecrest by the Donald Lacy residence needed approximately 40' of repair and the grade altered. Other streets suggested for repair were, College St. at the railroad track to Smiths Grove-Hays Road, Mill St. and Vincent Street. The commission discussed the repair of Vincent St. at length. They decided that the only alternative the city has at the present time is to continue patching and repairing it until such time the MA funds are built up so it can be rebased and resurfaced the right way. Barry Claypool ask if the city would consider paving a portion of Ridgecrest Drive in Highland Sub-division. He said he could see by the amount of funds available that the city couldn't do an awful lot of work. He also stated that he and Bud Greenup were still willing to pay half of the cost of this paving. Mayor Gilley said that according to the prevailing city ordinance, the city couldn't pave any sub-division street until such time it is paved with a hard surface. He told Mr. Claypool that if the MA funds are ever built up to allow the city to consider these streets, perhaps the ordinance could be changed to include sub-divisions. He ask the other commissioners if they had any streets to add to the proposed ones already named. They did not. With no further discussion to be had, Mayor Gilley declared the hearing closed.

PROPOSED FY 1989-1990 BUDGET HEARING

Mayor Gilley ask the commission if they had had time to review the proposed budget the clerk had submitted. Comm. Belcher presented a motion to accept the proposed budget as submitted, seconded by Comm. McGuffey. roll call and vote - Belcher yes, Gilley yes Stiffey yes, Crisp yes, McGuffey yes.
