**Cemetery Plots**

Commissioner Higginbotham said that as he had mentioned last month, the city's cemetery plots should be raised, to help the expenses for the cemetery.

He thinks the raise should be from \$275.00 to \$500.00. Mayor Watt said he thinks the plots should not go to \$500.00. Don't want to be a big jump to put hardship on the citizens. Commissioner Varner suggests \$375.00. Commissioner Martin thinks \$500.00 would be good. Mayor Watt said in one section you still could buy individual plots. The city can go with \$375.00 and see how the cemetery expense is working in a year or two. Mayor Watt asked the Commission if they have any more questions with none given. A motion was made by Commissioner Higginbotham to raise the plots from \$275.00 to \$500.00. Mayor Watt asked for a second with none given, died lack of second. Commissioner Higginbotham made a motion to raise the plots to \$450.00 Mayor Watt asked for a second none given died lack of second. Motion was made by Mayor Watt seconded by Commissioner Varner to raise the cemetery plots from \$275.00 to \$375.00 per plot. Roll call was taken: Roll call: Voting yes: C. Varner, C. Higginbotham, Mayor Watt and C. Martin. Voting no: none Mayor Watt said if no more discussion with none given, adjourned the meeting approximately at 8:10\_p.m.
