

City Commission meeting - May 24, 1993 - 7:00 p.m. - City Hall

Mayor Gilley Called the meeting to order with all commissioners in attendance.

He informed those in attendance that they would disperse with the agenda for the time being and allow Joe Lyle and Alan Valance from the Warren County Water District inform them of the progress of the city sewer system. ~

Mr. Lyle said they had submitted all of the plans and specifications for the system to the Division of Water in Frankfort for their approval. He anticipates that they will be able to advertise for the contract bids around June 30, 1993 and they would be opened in all probability, around the middle of July, 1993. He added in his opinion, the construction should be under way by mid-August. Connie Laws ask Mr. Lyles about the \$500.00 hook-up the people were required to pay. Mr. Lyle said they had been talking with Farmers Home Admin. to see, since the city had passed an Ordinance agreeing to all of the stipulations of the contract, the \$500.00 required hookup fee being one of these agreements, if the residents that weren't going to get the free hookups could wait until the sewer was actually under construction before they were required to put up any money. The Water Districts intent is to send letters to all of the residents, including those who will get free hookups and tell them they need to make their applications, and those that are required to do so, can, at that time, pay their \$500.00 or they would have the option to wait until the sewer is available. Comm. Belcher ask Mr. Lyle who would assist those that couldn't fill out the applications themselves. Mr. Lyle said the BRADD would assist them. Comm. Belcher also ask if the homes that the city was required to pay the hookups for be done at the same time as the rest of the homes. Mr. Lyles said they would. Alan Valance said he hoped everyone understood that the \$500.00 hookup fee did not include the actual installation to the peoples homes, just actually being hooked up to the system and a maximum of 50' form the street right away. Mr. Lyle ask the commission how they felt about the letters they proposed to send. All of the commission agreed they felt this would be a good idea. Mayor Gilley ask if there were any other questions to Mr. Lyle or Mr. Valance. There were none. Mayor Gilley thanked them for their time and information.

3. First reading Ordinance #93-1 920.13-approving the city/County Planning commissions to amend article 7 of the zoning Ordinance

Comm. Crisp presented a motion this Ordinance now be accepted for a second reading, seconded by Comm. Lacy. roll call and vote - Belcher yes, Gilley yes, Martin yes, Crisp yes, Lacy yes.

4. First reading Ordinance #93-1 220.14 amending the Mayor's salary

Comm. Lacy floored a motion this ordinance now be accepted for a second reading, seconded by Comm. Crisp. Roll call and vote - Belcher yes, Gilley abstain, Martin yes, Crisp yes, Lacy yes. The commission agreed to have the second reading of these two ordinances, Tuesday, May 25.

5. Department reports

Mayor Gilley read the monthly report, (attached), submitted by the police department for the commissions approval.

6. Other

Comm. Lacy reported he had talked with Moulder Construction regarding the required Handicapped improvements at the Smiths Grove Library. He said Mr. Moulder would look at the facility and give the city an estimate as soon as possible.

With no further business to be heard, a motion to adjourn was floored.
