

City Commission meeting - November 24, 1986 - City Hall - 7:00 a.m.

The meeting was called to order at 1:00 p.m. with Comm. Bryce, Barrow and Smith in attendance, as well as Mayor Gilley.

AGENDA

1. Minutes of previous meeting

The commission had ample time to review these minutes, and with no additions or corrections to same, Comm. Bryce presented a motion to accept them as written, seconded by Comm. Barrow. Roll call and vote - Smith yes, Gilley yes, Barrow yes, Bryce yes.

2. Treasurer's report

Comm. Bryce presented a motion to accept this report as printed, seconded by Comm. Smith. Roll call and vote - Smith yes, Gilley yes, Barrow yes, Bryce yes.

3. Solid Waste Management Plan

Mayor Gilley ask the commission if they had reviewed this report, and if so what was their opinions. After a brief discussion, they decided to table this issue until a future date and more time to better understand it. Comm. Bryce presented a motion to table this issue until a future date, seconded by Comm. Barrow. Roll call and vote - Bryce yes, Barrow yes, Gilley yes, Smith yes.

4. Planting of live tree by Lions Club in City Park

Mayor Gilley ask Comm. Bryce, as a member of the Lions Club to explain what their intentions were. Comm. Bryce said they would like the city's permission to plant a live tree in the park that would be a permanent one used from year to year, and as it grew they would top it. The commission was in complete agreement that the tree at Christmas time was a definite asset to the city and all appreciated their past efforts. Comm. Barrow presented a motion the Lions Club be allowed to plant a live tree in City park in the area of the flag pole to be a permanent one, seconded by Comm. Smith. Roll call and vote - Smith yes, Gilley yes, Barrow yes, Bryce yes. Comm. Bryce informed the commission the club intends to have the lighting

ceremonies at 5:30, 12/13/86 with Santa Claus lighting the tree and local choirs singing carols.

5. Resale of Community Development Lot #31

Mayor Gilley said that when the time came to pay the balance due on this lot, the Ronnie Pearson's didn't have the money. He ask the comm. how they wanted to handle this situation. They went into a lengthy discussion of the city's options. The decision was finally made to offer the lot to Mr. & Mrs. Albert Britt, and to Mr. and Mrs. Ronnie Pearson at the price of \$700.00 with a 12% daily interest charge added until the time the lot is sold. Comm. Bryce made the motion this letter be sent to the two above mentioned people informing them of the way the sale was to be handled, seconded by Comm. Smith. Roll call and vote - Smith yes, Gilley yes, Barrow yes, Bryce yes.

6. First reading of revised Occupational License Ordinance #86-3430.2

Mayor Gilley had given the commission time to review and contemplate the revised wording of this ordinance. He ask them their opinion of

the revision. Comm. Bryce ask what if the ones contacted still refused to pay the license fee. Mayor Gilley said with the \$5.00 per day fine, the city would then have basis to take them to small claims court. Comm. Bryce ask the clerk how she intended to inform the people of this new ordinance. She said she had intended to have an article printed in the paper with the new revisions. Comm. Bryce ask that at the time she sent out the notices of the license due, she inform them in some way of the changes. She agreed to do so. With no further discussion to be heard, Comm. Bryce floored the motion to accept this ordinance for a second reading, seconded by Comm. Barrow.

7. Other

The clerk asks the commission their feelings about having a Dec. meeting since it fell on the 22nd. All were in agreement; since there was nothing pressing they wouldn't have a meeting. And if something did arise they would call a special called meeting.

The clerk asks if the city employees were going to receive their usual Christmas bonus of \$25.00. Comm. Bryce presented a motion the clerk, police chief and cemetery superintendent receive their \$25.00 bonus, seconded by Comm. Smith. Roll call and vote - Smith yes, Gilley yes, Barrow yes, Bryce yes.

Comm. Bryce said he had been called regarding a cement street marker that been hit by cars and knocked down several times. There was no actual name on the markers and he wanted to know what the commission wanted him to do. It was decided he would check with the people who live in the area of 4th & Kentucky to see if they would rather have this repaired or have a street sign installed. He will report about this at the next meeting.

With no further business to be discussed a motion to adjourn was heard.
