Public Safety, Health & Welfare Report

Sealed Bids

Mayor Watt opened Scott & Murphy Inc.

Their total retail bid is 33,105, with a discount for the city, reduced to 29,550

He went on to read that there is an another option that they would like to propose, and that is if they can call the park (The Charles Morehead Memorial Park) and with that in mind they will do this project for \$4500. Not supplying the paved brick pavers.

Mayor Watt said, that Charles Morehead had been a long time residence of Smiths Grove served as Warren County Magistrate for 4 years, served as Warren County Clerk for 18

years. Mayor Watt said, he don't know about the rest of the Commission but he really likes this idea, and the cost well, you can't beat that, all the Commission was in

agreement Mayor Watt asked if he can get a motion on what bid the city will accept
