Minutes of the meeting of the Board of Trustees, Wednesday, October 3, 1962.

The Board met at 7:30 PM at the American National Bank and Trust Company with one member, Trustee Joe Lowe absent.

Minutes of the previous meeting were read and approved.

Clerk reported a balance in the general fund of \$4526.98 and in the fire truck fund of \$409.64. Mrs. Jordan reported the Cemetery fund as \$1575.24. The Hardy account now stands at \$450.00.

3. Marshall Britt was not present and sent no report.
4. The Industrial Development Board had no report.
5. Street markers were not discussed.
6. The Zoning Committee had no report as they have received no recommendations from the Board.
7. Chairman Jordan has not met with representatives of the rural fire truck to authorize payment of \$100 to help defray the expenses at the fire station.
8. There is nothing new concerning the filter for the water works. Attorney Charles Whittle has returned the copy of the franchise but has not returned the ruling of the Public Service Commission. When this is obtained, further discussion can be held on the problem of meters for all property.
9. The prospective police judge, W. A. Keener, cannot register until November.
10. Chairman Jordan reported he has contacted Magistrate Morehead concerning the black top and also McClellan concerning the repair of second street. This work needs to be completed while the weather is warm. Chairman Jordan said he would contact them again. Trustee Powell commented that First Street is in the same condition as Second. After a discussion, it was decided to wait until Second street is repaired so we can tell what the cost is before we decide to do any more repairs at this time. Trustee McGuffey commented that anytime the property owners are willing to pay $\frac{1}{2}$ of the cost of repairs, then we should do this. Chairman Jordan reported the property owners on Broadway might be interested in the chipping repair.
11. Clerk was asked to contact the L & N regarding the crossings.
12. The street by the Cemetery has been scraped. There are some holes which need rock.
13. Chairman Jordan reported he had called Sheriff Phelps to attend our meeting, but he was unable to do so. Chairman Jordan is to contact the State Police regarding extra help for Halloween. Trustee Madison is to acquire five State signs which state the fine for littering a public highway. These are to be placed on Main Street before Halloween.

14. Clerk is to write the parents of the boys who were involved in last year's Halloween mischief to remind them to stay at home this year.

15. Clerk reported there is no State law regarding false fire alarms. After a general discussion, it was decided not to pass the ordinance until we know the penalty as set forth in the Bowling Green ordinance pertaining to this offense. Clerk is to obtain this information.

16. A discussion was held on annexation. Chairman Jordan again asked the Board members to study this situation and be ready at the next meeting with their recommendations as to the boundary limits.

17. It was decided not to sponsor a Fall clean-up.

There being no further business, the meeting adjourned until the next regularly scheduled meeting the first Wednesday in November, 1962.
