

City Commission Meeting - September 28, 1987

Mayor Gilley called the meeting to order with Comm. Bryce, Barrow and Smith in attendance.

## AGENDA

### 1. Minutes of the August meeting

The Mayor called for any corrections or discussion of these minutes. With none to be heard, Comm. Bryce presented a motion to dispense with the reading of the minutes and to accept them as written, seconded by Comm. Smith. Roll call and vote - Smith yes, Gilley yes, Barrow yes, Bryce yes.

### 2. Treasurers report

With no additions or corrections to this report, Comm. Barrow presented a motion to accept it as printed, seconded by Comm. Bryce. Roll call and vote - Bryce yes, Gilley yes, Barrow yes, Smith yes.

### 3. First reading Ordinance #87-5 220.91-1988 vehicle tax rate

Mayor Gilley informed the commission the rate for 1988 would remain as it has been in the past, .36¢ per \$100.00 assessed value. Comm. Bryce presented a motion this ordinance be accepted for a second reading.

### 4. First reading Ordinance #87-6 220.90-1987 Property tax rate

Mayor Gilley said this rate of \$.19 per 100.00 assessed value had been derived by the clerk from a formula sent from Frankfort. Comm. Smith presented a motion to accept this ordinance for a second reading.

### 5. Discussion-insurance premium tax certificate of deposit

The clerk said she had received all of the pertinent information from The Equitable Insurance Co. proving that the \$36,144.15 had been sent to Smiths Grove in error. She now wanted to know if the commission wanted her to return the funds to them. After a brief discussion, Comm. Bryce presented a motion, if the funds had been

received in error to now return them, seconded by Comm. Barrow. Roll call and vote - Smith yes, Gilley yes, Barrow yes, Bryce yes.

Mayor Gilley ask the commission if Tuesday, 9/29/87 would be satisfactory with them to hear the second reading of the two tax ordinances. They agreed it would.

#### 6. Discussion-new street ordinance

Mayor Gilley ask the commission if they had compiled any type of ordinance. Comm. Bryce said he felt the new ordinance definitely should be based on the streets that were discussed at the Municipal Aid road Hearings and then a committee could survey those streets and then give priority to those that were in the worst shape. He also said he felt, if the city had the funds, he thought we should go 50% for sub-divisions but only those with the most houses and not one with no buildings like Barry Claypool's and Bud Greenup's. Mayor Gilley said Ralph Anderson was working on a resolution and a new ordinance and specifications and he felt maybe it would be a good idea to wait until the commission saw what he came up with. All agreed.

#### 7. Other

Comm. Bryce wondered if it was necessary to have a motion contained within
