ORDINANCE PROPOSING ANNEXATION TO THE
CITY OF SMITHS GROVE, KENTUCKY

WHEREAS, at a special meeting of the Board of Trustees of the City of Smiths Grove, Kentucky, a sixth class city, at which time all members of the Board of Trustees waived formal notice of said meeting, said Waiver being attached hereto and made a part herewith, and

WHEREAS, after due consideration, the Board of Trustees of the City of Smiths Grove, Kentucky, has considered and recommends the annexation into the City of Smiths Grove, the hereinafter described area, and

WHEREAS, the owners of said property are requesting this area to be annexed to the City of Smiths Grove, Kentucky.

NOW THEREFORE, BE IT HEREBY ORDAINED by the Board of Trustees of the City of Smiths Grove, Kentucky, pursuant to KRS 81.100, 81.120, 81.240 and 81.250, etc., as follows:

(1) That the following described real estate be annexed to the City of Smiths Grove:

Beginning at a post in the north right of way line of county road 1049, a common corner with property owned by Joe Lowe, thence North 2 degrees 7 minutes West, 1621.6 feet to a post, said post being a common corner with property owned by Joe Lowe; thence North 83 degrees 55 minutes East 394.1 feet to a post, a common corner with property owned by Joe Lowe; thence South 2 degrees 23 minutes West 1398.8 feet to a stake, being a common corner with property owned by Joe Lowe and property owned by C. M. Smith; thence North 84 degrees 45 minutes West 142.6 feet to a stake; being a common corner with property owned by C. M. Smith; thence South 3 degrees,

05 minutes West 89.6 feet to a post, being a common corner with property owned by C. M. Smith and property owned by Maurice Marr; thence South 86 degrees 44 minutes West 223.46 feet to a post being a common corner with property owned by Maurice Marr; thence South 1 degree 51 minutes West 174.5 feet to a post; being in the north right of way line of county road 1049, a common corner with property owned by Maurice Marr; thence South 86 degrees 44 minutes West 18 feet along the north right of way line of county road 1049, to the point of beginning.

The foregoing pursuant to a survey by G. A. Wilkinson, Registered Land Surveyor, No. 1343, dated the 6th day of October, 1976.

BEING the same property conveyed to James F. Jackson and Wanda Mae Jackson, his wife, from C. M. Smith and Mae Smith, his wife, by Deed dated the 23rd day of March, 1978, which Deed is of record in Deed Book 464, Page 554, in the Office of the Clerk of Warren County, Kentucky.

(2) That the City Clerk shall publish this Ordinance pursuant to KRS 424;

(3) That this Ordinance shall be in full force and effect upon signature, publication and recordation.
