**AN ORDINANCE AUTHORIZING THE EXECUTION AND DELIVERY OF A CONTRACT FOR A TERM OF THREE YEARS WITH MRS. ADLAI A. KIRBY FOR FURNISHING WATER TO THE TOWN OF SMITHS GROVE, KENTUCKY, FOR USE IN FIGHTING FIRES AND FOR PERMITTING THE FIRE DEPARTMENT OF THE TOWN OF SMITHS GROVE TO CONNECT WITH FIRE PLUGS FOR TRAINING THE FIRE DEPARTMENT AND PROVIDING FOR A YEARLY RENTAL OF \$300.00 payable semi-annually FOR THEIR CONTRACTUAL RIGHTS.**

THE BOARD OF TRUSTEES OF THE TOWN OF SMITHS GROVE, KENTUCKY, DO ORDAIN  
AS FOLLOWS:

That the contract dated July 3, 1944, between Mrs. Adlai A. Kirby designated as Owner therein as party of the first part and the Town of Smiths Grove designated as the User as party of the second part providing for the owner to permit the Town of Smiths Grove to connect its fire equipment with her fire plugs for fighting fires arising in Smiths Grove and to use water for that purpose and to connect with her fire plugs not exceeding twelve times per calendar year for training its fire department in using its fire fighting equipment and providing for a yearly rental of \$300.00 with one-half of same payable on July 1 and the other half on January 1 of each year during the term of the contract, be, and the same hereby is, approved for execution and delivery by the Town of Smiths Grove simultaneously with the owner's acquiring a franchise to use the streets, alleys, lanes and public places of the Town of Smiths Grove in laying mains and water lines in connection with her water works system.

It is ordained that the contract will be executed in the name of the Town of Smiths Grove by Dr. J. B. Helm, Chairman of the Board of Trustees, duly attested by P. H. Butler as clerk and that the same will become effective immediately upon the owner's acquiring good and legal franchise for the purpose stated.
