WHEREAS, it came to the attention of the Board of Trustees of the City of Smiths Grove, Kentucky, that confusion existed as to the responsibility for the payment of real property taxes where new construction has taken place during a calendar year; and ----- the Board of Trustees of the City of Smiths Grove, Kentucky, a sixth class city, has considered the problem and has recommended That all property taxes on property involving new construction during a calendar year shall be paid pro-rata as of the date of occupancy;

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the City of Smiths Grove, Kentucky:

That if during the calendar year new construction takes place On real property located within the City of Smiths Grove, Kentucky, then and in that event, the owner shall be pro-rata responsible for the increase in value as of the date of occupancy of the new construction.
