112.3 78-2 (ANNEXATION PROPOSAL ORDINANCE)

BE IT ORDAINED BY THE BOARD OF TRUSTEES, OF THE CITY OF SMITHS GROVE:

SECTION 1: It is deemed desirable and the Beard of Trustees of the City of Smiths Greve, Smiths Greve, Kentucky, is proposing to annex certain territory to the City of Smiths Greve, Kentucky, and it is proposed that the corporate limits of the City of Smiths Greve, Kentucky, as now established be now extended so as to include the territory hereinafter described and to annex the property hereinafter described to the City of Smiths Greve, Kentucky, viz:

Beginning at a point in the north right of way line of I-65 and on the existing south corporate limits of Smiths Grove in Warren County, Kentucky; said point being opposite station 1270 +00 on the center line of I-65 thence traversing the I-65 right of way S 04 01' 16" W, 300.0 feet to the south right of way line of I-65 thence following the right of way line of I-65 S 88 26' 10" W, 430.0 feet, S 77 01' 16" w 205.5 feet, S 60 30' 16" E, 158.1 feet, and S 77 01 " 16" w 30.0 feet to an iron pipe, thence turning and traversing the land of Mrs. Benton Anderson S 8 20 W, 370.0 feet to a fence post; thence turning and going N 83 25' E 46.8 feet to an iron pin; there turning and going S 5 16 W, 238.45 feet to an iron pin and continuing S 5 16 W, 103 feet; there turning and going N 76 20' W, 288.2 feet to a post common te Tarter, there fellowing Tarter's line N 2"55' E, 122.0 feet te the east right of way line of Kentucky 101, thence going N 59"15' W, 45.0 feet to the center line of Kentucky 101, thence following the center line along a 5 00 circular curve 504.67 feet, and thence N 4 00' 16" E. 285.81 feet to the center line of I-55 (station 1259 + 23.9) thence along the center line of I-65 S 85 59 44 E, 897.40 feet to station 1268 + 21.30; there turning and going N 04 00' 16" E. 162.5 feet to the north right of way line of I-65 thence fellowing said right of way line S 81°59' 44" E, 170.70 feet te the beginning.

SECTION II: That this ordinance shall be published and advertised for not less than three (3) consecutive days in the Park City Daily News, a newspaper published in said city and Warren County and

which is designated public printer of the City of Smiths Grove, and is the newspaper of the largest circulation in the City of Smiths Grove, Kentucky.

SECTION III: That this ordinance shall be in full force and effect from and after its adoption, approval and publication and all ordinances or parts of ordinances in conflict herewith are hereby repealed and held for naught.
