

AN ORDINANCE RELATING TO THE MERGER OF THE FIRE
DEPARTMENT OF THE CITY OF SMITHS GROVE,
WITH SMITHS GROVE RURAL FIRE DEPARTMENT
ORDINANCE # 85-1 310.4

Be it ordained by the City Commission of the City of
Smiths Grove, Kentucky:

Whereas, the City of Smiths Grove, Kentucky and the
Smiths Grove Rural Fire Department, Warren County, Kentucky
desire to merge their respective fire departments to enable
the Smiths Grove Rural Fire Department to provide fire
protection to the City of Smiths Grove, Kentucky, it is
hereby ordained as follows:

(a) The City of Smiths Grove, Kentucky shall turn over
to the Smiths Grove Rural Fire Department all funds
presently held in the City of Smiths Grove, Kentucky "Fire
Truck Fund."

(b) The Smiths Grove Rural Fire Department and the
City of Smiths Grove, Kentucky shall enter into a contract
in which the City of Smiths Grove, Kentucky will pay
\$1,500.00 per year to the Smiths Grove Rural Fire Department
for protection with said payment to be renegotiated between
the City of Smiths Grove, Kentucky and the Smiths Grove
Rural Fire Department with the taking of office of each new
commission of the City of Smiths Grove, Kentucky.

(c) The Smiths Grove Rural Fire Department and the
City of Smiths Grove, Kentucky shall enter into a contract
in which the City of Smiths Grove, Kentucky shall lease its
fire truck to The Smiths Grove Rural Fire Department for the
sum of One Dollar (\$1.00).

CONTRACT FOR FIRE PROTECTION


The City of Smiths Grove, Kentucky acting by and through its duly elected Mayor, James F. Jackson, pursuant to City Ordinance No. 85-1 310.4, and the Smiths Grove Rural Fire Department County, Kentucky acting by and through Kenneth Priddy, Fire Chief, Smiths Grove Rural Fire Department,


WITNESSETH:

Commencing with the execution of this contract, the City of Smiths Grove, Kentucky agrees to pay to the Smiths Grove Rural Fire Department the sum of One Thousand Five Hundred Dollars (\$1,500.00), each year for fire protection to be provided by The Smiths Grove Rural Fire Department to the City of Smiths Grove, Kentucky. Upon inception of each new commission of Smiths Grove, Kentucky, the amount payable to Warren County, Kentucky under the terms of this contract will be renegotiated between the City of Smiths Grove, Kentucky and the Smiths Grove Rural Fire Department.
