

ORDINANCE # 92-1 310.5 AMENDING ORDINANCE
85-1 310.4 RELATING TO THE MERGER OF THE
FIRE DEPARTMENT OF SMITHS GROVE CITY WITH
THE SMITHS GROVE RURAL FIRE DEPARTMENT

WHEREAS: The city of Smiths Grove, Kentucky and the Smiths Grove Rural Fire Department, by the above stated Ordinance, merged as of 10/31/1985, and

WHEREAS: The City of Smiths Grove, Kentucky agreed to, by contract dated 10/31/1985, to pay an annual fee of \$1,500.00 per year to the Smiths Grove, Rural Fire Department for city fire protection with said payment to be renegotiated between the city of Smiths Grove, Kentucky and the Smiths Grove Rural Fire Department with the taking of office of each new city commission.

NOW, THEREFORE BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF SMITHS GROVE, KENTUCKY:

Through and by an unanimous vote of the City Commission 5/26/1992, the City of Smiths Grove, Kentucky will pay an annual fee of \$3,000.00 to the Smiths Grove Rural Fire Department for city fire protection, with a mutual agreement between the Smiths Grove City Commission and the Smiths Grove Rural Fire Department, this fee of \$3,000.00 is non-negotiable for a period of five years.


CONTRACT FOR FIRE PROTECTION

The city of Smiths Grove, Kentucky acting by and through its duly elected Mayor, James R. Gilley, pursuant to City Ordinance No. 85-1 310.4, and amended by Ordinance No. 92-1 310.5, and the Smiths Grove Rural Fire Department, acting by and through Willie Pierce, Fire Chief, Smiths Grove Rural Fire Department,


WITNESSETH:

Commencing with the execution of this contract, the city of Smiths Grove, Kentucky agrees to pay to the Smiths Grove Rural Fire Department the sum of three thousand dollars, (\$3,000.00), each year for fire protection to be provided by the Smiths Grove Rural Fire Department to the city of Smiths Grove, Kentucky. Upon inception of agreement to this contract, both parties have agreed that this figure of \$3,000.00 annually would not be renegotiated for a period of at least five years, between the city of Smiths Grove, Kentucky and Smiths Grove Rural Fire Department.
