REVISING ZONING ORDINANCE SECTION REFERENCES IN CITY ORDINANCE # 94-1 920:15 AMENDING THE SMITHS GROVE ZONING ORDINANCE

The City Commission of the City of Smiths Grove, Kentucky does adopt the attached amendments to the Smiths Grove, Zoning Ordinance, Sections 626.1, 636.1, 646.1, 651.1, 661.1, 671.1 and 681.1 all relating to minimum lot size.

, SECTION 610 SINGLE-FAMILY RESIDENTIAL (R-1) DISTRICT.

626.1 Minimum Lot area. Where served by public sanitary sewer, the lot area shall be no less than 13,500 square feet. The lot area shall not be less than 20,000 square feet where public sanitary sewer is not available of which. sSixty-five (65) percent of the lot area shall be retained as unobstructed open space.

SECTION 630 TWO-FAMILY RESIDENTIAL (R-2) DISTRICT.

636.1 Minimum lot area.

Where served by public sanitary sewer, the lot area for a singlefamily structure shall not be less than 10,000 17,000 square feet; for a two-family structure shall not be less than 13,500 20,000 square feet. Where public sanitary sewer is not available, the lot area for a single family structure shall not be less than 43,500 square feet and for a two-family structure shall not be less than 54,450 square feet. Each lot shall retain not less than 50% of the lot area as unobstructed open space.

SECTION 650 GENERAL COMPLEX GIAL (C-PARISTRE)

SECTION 640 MULTI-FAMILY RESIDENTIAL (R-3) DISTRICT

646.1 Minimum lot area.

Where served by public sanitary sewer, the lot area for a single-family structure shall not be less than 8,000 17,000 square feet; for a two-family structure shall not be less than 11,000 17,000 square feet for the first unit and shall not be less than 3,000 square feet for each additional unit. Where public sanitary sewer is not available, the lot area for a single family structure shall not be less than 43,500 square feet and for a two-family structure shall not be less than 54,450 square feet. Multi-family structures for more than two families are not permitted where sanitary sewer is not available. Each lot shall retain not less than 50% of the lot area as unobstructed open space. On individual sewage system 4 units are maximum on each lot:
