The brackets will cost for all 3 \$ 158.00. Motion was made by Varner second by Martin to have Signature Signs do the banners for a total of \$ 729.50 and Econo Signs do brackets for a total of \$ 158.00. Ayes: All members present.

Mayor Watt read a letter from the Bob & Jackie Lightfoot they have a concern that affects their business at Bryce Inn, Jake-brakes the tractor trailers are doing in the middle of the night and causing problems with their customers. City Attorney Wes Milliken said he will see if he can contact the individuals that are recommended by the Lightfoot's and see if the city can help them out.
