Minutes of the meeting of the Board of Trustees of the City of Smiths Grove, April 3, 1956.

The Board met at 7:30 PM, Tuesday, April 3, 1956, in the Director's Room of the Deposit Bank, with all members present and the following business was transacted:

- 1. Letter to Governor Clerk was directed to write a letter to the Governor about appointment of Mr. W. P. Demuth as City Judge. For signature of Mrs. Stone.
- 2. Power Mower at Cemetery Discussion as to what to do, etc. Mr. Tarter was delegated to check with Cooke and Ewing Hardware and find out what they would get a mower for. A $2\frac{1}{2}$ HP, 4 cycle, 20^{tt} SP Mower was recommended.
- 3. Clean-up time The Board has designated Monday as start of clean-ip week. Mr. Lowe is delegated to try to find someone to help pick up junk. He will ask Morris Parrish and Clint Hayes if they will help. The telephone operators will be requested to notify people who have phones about their junk.
- 4. Mrs. Stone will talk to Mr. Logan about cutting out undergrowth at Mrs. Hampton's place at 6th and Main.
- 5. Limbs on Maon Street which hang onto trucks, etc. Mrs. Stone reported that she has talked to Joe Mitchell and he has promised to see if the REA will trim same.
- 6. Traffic on Main Street Due to more traffic on Highway 101 something must be done about the congestion.
 - 7. Trash cans Lion's Club has secured 4 cans City must secure cans to walks.
- 8. Street Markers Several have been torn down by Mr. Garman's, below Lumber Yard and down in Colored section.
- 9. The Clerk is directed to write letter to Lion's Club expressing thanks for their interest in installation of street markers, trash cans, etc. Chairman and Marshal will talk to Mr. Meredith about location of cans.
- 10. Clerk reported that Cecil Elmore wasn't too pleased about the letter which we wrote about cleaning up lot since he had not as yet purchased the lot.
- 11. Marshal and Judge turned \$19.00 for Lester Lawrence, \$19.00 for Jr. Magers, \$22.00 for Ray Hawks and \$22.00 for Grady Lawrence fines over to clerk.
 - 12. Tax Collections (Hack taxes) Marshal says he is working on same.
- 13. Clerk to write Paul Elkin letter to appear before the Judge at 10:00 AM, Thursday, April 12, 1956.
- 14. After a discussion on the tank which the Volunteer Fire Department had installed on the Fire Truck from their own fund Mr. Tarter made the motion and Mr. Denton seconded, that City reimburse the Fire Department \$61.00 for same. There were no dissenting votes.
