CITY OF SMITHS GROVE SMITHS GROVE, KENTUCKY

The Board of Trustees of the City of Smiths Grove met at 7:00 PM, Tuesday, December 4, 1956, and the following business was transacted:

- 1. The Clerk gave a financial report and a discussion on back taxes, fines, etc. was held.
- 2. Ex-Chairman Melton was present and explained about some oil which the City had stored in the tank of the City of Bowling Green. He stated that when Broadway was built it was figured that it would take some \$1,100.00 worth of oil to do the job and that was the amount we paid. After a discussion of a previous meeting between Mr. Akers of the Asphalt Products Company of Nashville, Tennessee, and the Presidents of the PTA, Lions Club and Chairman of the Board of Trustees it was agreed that the oil which has been in question for a good long while was used in Smiths Grove whether on the school grounds or on the streets it is not known since there was a mixup in bills.
- 3. When asked how much money he thought that the City should borrow to meet current obligations the Clerk stated that he would advise getting \$1,500.00 to pay McClellan Stone Company \$930.00 for balance of stone used on College Street and approximately \$600.00 which is the disputed amount which it was agreed might be the City's part of the oil.
- 4. A motion was made by Mrs. Crump, seconded by Mr. Tarter, that McLellan Stone Company be issued a check for \$930.12 and Asphalt Products Company be issued a check for \$594.72 to clear these two bills. There was no objections and the clerk was authorized to issue the checks.
- 5. A motion was made by Mrs. Crump, seconded by Mr. Denton, that City borrow \$1,500.00 from the Deposit Bank to pay these bills. There were no objections to the motion.
- 6. After a discussion of the parking lot situation on the lot belonging to the Louisville and Nashville Railroad Company a motion was made by Mr. Tarter, seconded by Mr. Lowe, that Mrs. J. M. Stone as Chairman of the Board be authorized to sign a lease with the Louisville and Nashville Railroad Company for .77 acres of land behind the freight depot in Smiths Grove, Kentucky, said lot running 100 feet with main street and tapering off to 60 feet at end toward Louisville on an annuan rental basis of \$50.00. The motion carried unanimously.
- 7. A motion was made by Mr. Tarter and seconded by Mr. Denton, that City pay \$50.00 on the gravel used on Wayne Street from Fourth to Fifth Streets
- 8. Clerk to issue receipt to Judge Demuth of \$38.00 for Calvin Lawrence and Jessie Branham fines.
- 9. Bill to Dr. Helm for \$20.00 Discussion as to whether City should pay bill No action taken.

There being no further business the meeting was adjourned.
