Board of Adjustments

Commissioner Varner questions will there be a cost to the City? Mayor Gilley asked Andy Gillis if he could go ahead and explain what the benefits will be for the City to have Bowling Green take the BOA.

Andy Gillis said that there is an inter government agreement that was established in around 2001, there really will not have to be an amendment, what ever Ordinance's or other type of change over, get with the City Attorney for those changes.

To get someone to represent the City of Smiths Grove there might be 1 if not two seats open in June. Andy said he would talk with Judge Buchanon to see ifhe can recommend someone from Smiths Grove to serve on the BOA.

There are 7 members who serves on the BOA, 4 from the City and 3 from the county. As far as an expense they're really would be none other than the \$1200.00 that Planning & Zoning had waived last year because it was not in the budget, but he suggests we go ahead and pay that every year. It still will be a lot cheaper in the long run. Steve Hunter said he highly recommends that the City merge, because they do have the BOA Attorney present in every meeting, televised, and each one of the members takes all of the required courses that needs to be taken to educate them, for Use Conditional Permits, Variances and other permits. Andy Gillis said that if someone from the board would like to attend the next meeting, to see how they do business the next one is on February 24, 2005 held at 7:00p.m. At the Fiscal Court. Everyone was in agreement to have City Attorney Wes Milliken go ahead and go.

Mayor Gilley said table this until next meeting on February 28, 2005.

Commissioner Marr said he has an idea that they can hire on a multi person who can do a task of all things eliminated cleaning service, have them do other things when the clerk don't need them. Commissioner Pierce said he thought that would be a good idea also they can also do away with the mowing and that would help to pay for a part time or full time position. Commissioner Watt said he does not agree with the mowing being taken out because of the equipment and all.
