Smiths Grove, KY
Jan. 10 - 1938

Continuation of meeting of Jan. 3, 1938.

Present: W. C. Simmons, J. B. Helm, E. Wade, J. E. Bohannon, Judge Witherspoon and Marshal – Middleton.

Meeting called to order by Chairman Chs. Simmons.

Motion by J. B. Helms & sec. by E. Wade to appoint a committee to select a room for meetings of the town board and to hold court meetings.

E. Wade was appointed on this count. Chairman authorized Wasrren Co. Clerk or whoever is the proper authority to furnish list of real estate & personal property to town Board for the purpose of making the tax list of the town as same had been taken when ti should have been.

Motion by J. B. Helm, sec. J.E. Bohannon to fix \$10.00 unloading on trucks making regular delivery in town, and must unload at back of place of delivery wherever it be possible to do so, said vote was unanimous.

Motion by J. E. Bohannon, sec. by E. Wade that a special tax of 20 cts. per \$100.00 be levied on real estate & personal property for repairing & building streets to be paid on 1938 tax assessment. Vote was unanimous.

Motion by E. Wade, sec J. B. Helen that the License for selling beer in the town of Smiths Grove, KY be set at \$50.00 due and payable as of Jan. 1, 1938.

Said License are not transferable, and are void where used by any other person or firm to whom they were originally issued, and one License to cover only one location. Vote on same was unanimous.

Motion by E. Wade & sec. J. B. Helm that license for restaurants be fixed at \$10.00 per year. Coal dealers (T) at \$10.00 per year. Ice dealers (T) at \$5.00 per year. Feed dealers (T) at \$5.00 per year. Gen. Mdse stores at \$20.00 per year. Drug stores at \$20.00 per year. Millinery Stores at \$6.00 per year. Banks at \$20.00 per year. Grocery Stores at \$12.00 per year. Produce dealers at \$15.00 per year. Barber Shops at \$5.00 per year. Lumber dealers at \$10.00 per year. Service Stations at \$15.00 per year. General Garages at \$15.00 per year. Undertakers at \$12.00 per year. Antique dealers at \$6.00 per year. Physicians & Dentists at \$10.00 per year. Water Works at \$20.00 per year. Milling Co. at \$15.00 per year. Paint Shops & Shoe Shops at \$5.00 per year. Hardware Stores \$20.00 each per year. Billiard Parlors \$5.00 each per year. Meat Markets \$5.00 each per year.
