Minutes of the meeting of the Board of Trustees, Tuesday, January 4, 1966.

The Board met at the Smiths Grove Bank with all members present.

- 2. Chairman Melton complimented Carl Rasdall on his efforts for the water system and suggested him as Vice Chairman. Trustee Rasdall said he appreciated the opportunity but felt with his business he would prefer to spend his time on work for the water system. He then nominated Trustee Powell. Trustee Lowe made a motion that nominations cease. Trustee Blackwell seconded the motion. Trustee Powell is the Vice Chairman of the Board.
- 3. The present city employees were discussed. Trustee Rasdall made a motion seconded by Trustee Blackwell that the present city clerk, Gertie Bybee, be retained for the present time. There were no dissenting votes.
- 4. Trustee Powell made a motion seconded by Trustee Lowe that clerk wrote Governor Breathitt relative to the appointment of J. W. Blue as police judge. There were no dissenting votes.
- 5. Trustee Gene Blackwell made a motion seconded by Trustee Rasdall that Bethel Denton be retained as night watchman for the present time. There were no dissenting votes.
- 6. Trustee Joe Lowe made a motion seconded by Trustee Blackwell that Carrie Lee Jordan be retained as cemetery supervisor for the present time. There were no dissenting votes.
- 7. Trustee Blackwell made a motion seconded by Trustee Lowe that Marshall Parrish be retained as cemetery custodian. There were no dissenting votes.
- 8. Trustee Blackwell presented excerpts from the minutes of the Lions Club to the effect that the city has no jurisdiction over the rural fire truck.
- 9. It was decided the Board would hold its regular meeting on the first Tuesday night in each month at 7:30 PM.
- 10. The following committee chairmen were appointed: Gene Blackwell, fire department; Bill Powell, streets; Joe Lowe, cemetery and Carl Rasdall and Tommy Melton, water.
- 11. Clerk was asked to notify the newspaper of the board meetings.
- 12. Trustee Rasdall made a motion seconded by Trustee Blackwell that the city financial report for 1965 be posted. There were no dissenting votes.
