Minutes of meeting of Board of Trustees, Tuesday, January 6, 1953.

The Board met at its regularly scheduled meeting at 7:30 P.M., Tuesday, January 6, 1953, in the Director's Room of the Deposit Bank.

Members Present: Chairman Melton, Mrs. Crump, Mr. Barlow & Mr. Madison.  
Members Absent : Mrs. Stone.

The meeting was called to order and the following business transacted:

**Tax Lists:** As regards a question of the City Clerk as to listing of taxes the Board ruled that the same list as used for 1951 taxes would be used unless any tax payer came in to list their property differently. In that case a Board of equalization will be appointed to review the case.

**Cemetery Road:** Mr. Anderson has promised to patch it as it is a County road. He will also grade and gravel Hedge Street.

**Ordinance on Unloading License:** Clerk to send copy to Swift and Company, but check with Mr. Logan as to wording of it.

**Trees at Mrs. Lucy Owens** which were damaged by fire at old gymnasium and have since died: Since they are between sidewalk and street the Board decided that technically they are on City Property. Mr. Madison is to see if someone will cut them to use for wood in the oven on the school ground.

**Bells for Signal Lights on Main Street Crossing:** Clerk to write Mr. J. T. Davis, Agent of L & N R. R. Co. asking him to inquire as to how to get bells installed as they would probably aid in preventing fatal accidents in future.

**ORDINANCE:** Motion made by Mr. Barlow, seconded Mr. Madison, that no trucks from 1½ Tons up be parked on Main Street between Stock Street (at Water Works) to 2nd Street (at Priddy's Service Station). Penalty for violation \$1.00. All ayes.

**ORDINANCE:** Motion made by Mr. Barlow, seconded Mrs. Crump, that speed limit in Smiths Grove be set at 25 miles per hour. Signs to be placed reading such. All voting aye. Mr. Madison to see State Highway Department about getting signs from them to be placed at each end of Main Street.

**ORDINANCE:** Not passed. An ordinance to the effect that a fine would be imposed for parking by fire plugs. Due to the plug in front of the Post Office being in such an unhandy location it was decided to wait until Ford Thomas could be contacted as to possibility of moving this plug. It is felt that no fines could be imposed here since this plug is in such a place.

The meeting then adjourned.
