Minutes of the Meeting of the Board of Trustees, Tuesday, June 2, 1959.

The Board met at 7:30 P.M. in the Director's Room of the Smiths Grove Branch of the American National Bank and Trust Company and all members were present. The following business was transacted:

- 1. Minutes of the previous meeting were read and approved.
- 2. Police report: Mr. Cassady reported that James Vance was fined \$25 for drunk and disorderly conduct. Leon Christy was charged with reckless driving and fined \$25. Mack Auto Supply paid their unloading taxes. Ewell McCoy and Clifton Murray paid back taxes. Mrs. Joe Underwood, Arch Lucas, Beverly Evans and Thomas Webb all paid \$1 parking tickets.
- 3. Trustee Thomas reported that Riley Whittle has a door which might be used for the remodeling of the fire station. This door can be bought for \$35. It was the opinion of the Board that this was a good price and Trustee Denton and Thomas were authorized to proceed with the necessary repairs and get the work done as cheaply as possible. It was thought the work might be done for approximately \$175.
- 4. Trustee Thomas had no report on the liability.
- 5. The lighting of the school grounds was again discussed and it was the consensus of the Board to hold this in abeyance until we see what steps the PTA takes.
- 6. All members agreed to drop the question of the old city building for the present time.
- 7. Trustee Thomas reported that he had the "no dumpng" signs and some "no parking" signs. Chairman Smith suggested that perhaps Marshall Parrish could erect these signs. Trustee Thomas volunteered to go with Chairman Smith and Marhall Parrish and show him where to put the signs.
- 8. Chairman Smith suggested that Mr. Cassady patrol the entire length of Main Street for improper parking.
- 9. Trustee Thomas reported that he appeared before the Railroad Commission in Frankfort and represented this section in his appeal for keeping the station open. As yet the station is not closed. The Railroad Company has been asked for additional data. If this additional information proves that the station is at least holding its own, it was the opinion of Trustee Thomas that perhaps we could keep the station. He further reported that he had read a letter which Agent Davis had received and the writer was well pleased with the hearing. Also, Mr. McKinney seemed to be well pleased with the report.
- 10. Chairman Smith reported there had been numerous complaints about the dust from the rock which were spread on College Street. It was his opinion that perhaps the next time the street leaks, brooms could be used to sweep the gravel from the sides to the middle of the street.

- ll. Trustee Anderson reported that Mrs. Mae Ewing had called her concerning the purchase of a lot at the cemetery which contained two trees. Mrs. Ewing wanted the trees removed. It was suggested that the Board Members go to the Cemetery before the next meeting and investigate this particular lot to see about the trees. No decision is to be made untid the next meeting.
- 12. Clerk presented the problem of the irregular lots in the new section of the cemetery. Clerk was authorized to contact Buddy Keith regarding this situation and invite him to the next meeting.
- 13. A discussion was held as to the correct proceedure in case of an arrest while the Judge is sick. Mr. Cassady said that Mr. Anderson could serve. Chairman Smith asked the opinion of the Board as to whether the State Patrol could patrol this town and make arrests. The Board asked Chairman Smith to call the Sergeant to see if this could be done. Mr. Cassady was asked to invite a deputy to assist him in patrolling on Saturday night.
- 14. Clerk was given a list of the follwing to send license notices: Scott Tobacco Co., Mrs. W. L. Martin, Dr. Pepper, Marshall Fruit and Vegetables Bob White Packing Co., L. H. Nickols, Jr., Ayers Bottling Co., Grapette and Mrs. Howard Pearson.

There being no further business, the meeting adjourned until the next regularly scheduled meeting the first week of July.
