

CITY COMMISSION MEETING - JUNE 20, 1994 - 7:00 P. M. – CITY HALL

Mayor Gilley called the meeting to order with Comm. Belcher, Hardy and Lacy in attendance for roll call and votes.

AGENDA

1. Minutes of the previous meeting

Additions or corrections to these minutes was called for by the Mayor. With none to be heard, Comm. Belcher floored a motion the minutes be accepted as written, seconded by Comm. Hardy. Roll call and vote - Belcher yes, Gilley yes, Hardy yes, Lacy yes.

2. Treasurers report

The clerk informed the commission this was the final report of this fiscal year. With no further discussion, Comm. Lacy presented a motion the report be accepted as printed, seconded by Comm. Belcher. roll call and vote- Belcher yes, Gilley yes, Hardy yes, Lacy yes.

3. First reading Ordinance #94-1 220.21 amending FY 93-94 Ordinance #93-2 220.16

Mayor Gilley explained this was an ordinance to amend the budget the city has just completed. Comm. Belcher presented a motion to accept this ordinance for a second reading, seconded by Comm. Lacy. Roll call and vote - Belcher yes, Gilley yes, Hardy yes, Lacy yes.

4. First reading Ordinance #94-2 220.22 FY 94-95 Budget

Commissioner Belcher presented a motion this ordinance be accepted for a second reading, seconded by Comm. Hardy. roll call and vote - Belcher yes, Gilley yes, Hardy yes, Lacy yes.

5. First reading Ordinance #94-1 610.7-Providing for the sale of the twenty year franchise with Western Kentucky Gas Company

Mayor Gilley introduced Mr. Jerry Harmon and Mr. John Paris from Western KY Gas Company. Mr. Paris explained that the city has had a twenty year franchise with the company since 1954 and it is now due for renewal. The above named ordinance must be passed with two readings before they can advertise bids for this franchise. Mr. Paris said if they were awarded the franchise they would suggest two ways for the commission to accept the bids. One would be a price per meter and the other would be based on the revenue generated in the city by the use of gas. Comm. Belcher ask if there is a proposal included to run lines into outlying and present sub-divisions. Mr. Paris said not at the present time but his company would be glad to have a survey run in any particular area to see if there was a need. Mr. Paris said it was obvious that the more gas used the more income the company generated. With no further questions or discussion, Comm. Lacy presented a motion the above named Ordinance be accepted for a second reading, seconded by Comm. Hardy. roll call and vote - Belcher yes, Gilley yes, Hardy yes, Lacy yes. Mayor Gilley said the second reading of the above three ordinances had been published to be read, Tuesday, June 21, 1994 at city hall. All of the commission agreed to this time.

6. Department reports

Police Department - Comm. Hardy read the report prepared by the Police Dept. (copy attached). Mayor Gilley said the city police car was in need of some new tires. The clerk ask that this expenditure be put off until after 7/1/94 when the new budget was in effect. The chief agreed to get bids for the tires and report to the commission on the cost of same.

With no further business to be heard, a meeting to adjourn was floored.
