Mayor Gilley called the meeting to order with Commissioner Crisp, Smith and Bryce in attendance, as well as several interested citizens.

1. Minutes of previous meeting

The commission had reviewed these minutes prior to the meeting, and with no additions or corrections to same, Comm. Smith presented a motion to accept the minutes as printed, seconded by Comm. Crisp. Roll call and vote - Crisp yes, Smith yes, Gilley yes.

2. Treasurer's report

The clerk informed the commission this would be the last treasurer's report for the fiscal year 1986-1987 budget. The Mayor called for any questions or discussion to the report. With none to be heard, Comm. Crisp presented a motion to accept the report as printed, seconded by Comm. Smith. Roll call and vote - Smith yes, Crisp yes, Gilley yes, Bryce yes.

3. First reading Budget Amendment Ordinance #87-2 220.88

The commission reviewed the above stated budget amendment for FY 1986-1987. Comm. Bryce presented a motion to accept same for a second reading.

4. First reading FY budget Ordinance #87-3 220.89

Having previously approved the drafting of this budget, Comm. Smith presented a motion to accept same for a second reading.

The Mayor informed the commission the second reading of these two ordinances would be heard, Tuesday, June 23 at 9:00 a.m. at city hall.

5. Consideration of estimates for termite control of city hall

Mayor read the three quotes as follows: Orkin, \$766.00, Allpest \$550.00, Guarantee Pest Control \$300.00. After a brief discussion of the bids Comm. Crisp presented a motion to accept the bid of the Allpest Co. for \$550.00, seconded by Comm. Bryce. Roll call and vote- Bryce yes, Gilley yes, Crisp yes, Smith yes. The clerk agreed to inform the company of the commission's decision.

6. Other

Mayor Gilley ask the citizens in attendance if they had anything to discuss. Mr. Jimmy Jackson wanted to know when College Street in his sub-division was going to be paved. He said he had talked with Mark Flener, the city attorney, and he told him that College was definitely a street and that the ordinance in question made it legal for the city to pave this street. Mayor Gilley said he had talked with John Metheny at Planning & Zoning and his office wasn't able to come up with the city ordinance which named the street and neither could the clerk. He added, at the time the city passed the ordinance annexing the land into the city, the then presiding commission, accepted a gravel street along with the land, and College Street wasn't anywhere in the Ordinance. Mr. Jackson said the city took in the sub-division and a street, why does the street have to have a name? Mayor Gilley said because this was the way Mr. Metheny had told us it was to be done. A street must be named by Ordinance. Comm. Bryce said to his knowledge, there were only two streets in Smiths Grove which weren't paved. College on the upper end, and the upper end of Webb Ave., Comm. Crisp wondered about the street that ran by Donald Law's residence. He said Mr. Frank Russell had paid for all of the gravel that was put on the street the whole time he was living. Mayor Gilley said the clerk had written to the Attorney General for opinions regarding the ordinance's legality and the decision would have to wait until we received his reply. Mr. Thomas Webb ask if he could have a few minutes of the commission's time on behalf of the people in his sub-division., Mr. Webb explained all of the particulars that were involved in developing the Webb Sub-division along with the attorney fees he had personally paid to get the area taken into the city limits. Now his question to the commission was, why, when they paved Webb Ave. they didn't continue around the corner to the two new houses he had built 3 to 4 years ago. Mayor Gilley replied the same thing applied here that applied to Mr. Jackson. According to the prevailing ordinance, when a street is blacktopped, then the city maintains it. Mr. Donald Laws ask the commission, if when his funds became available, if it was alright for him to gravel and grade Smiths Grove Road by his house. Comm. Smith presented

a motion to allow Mr. Laws to do this work, seconded by Comm. Crisp. Roll call and vote - Bryce yes, Gilley yes, Crisp yes, Smith yes

With no further business to be presented, a motion to adjourn was heard.
