Minutes of the Meeting of the Board of Trustees, March 2, 1954.

The Board met as usual at 7:00 PM, in the Director's Room at the Deposit Bank, and after being called to order the following business transacted:

l. A discussion of the Shobe-Mitchell contraversary over the Cemetary Lot. Mr. Rex A. Logan, City Attorney, was present and upon his advice the following motion was made and passed:

Upon a motion of Mrs. Stone, seconded by Mr. Denton, the Clerk was instructed to issue Deed to Mr. Joseph S. Mitchell for the half of Lot No. 5, the Lot in question, adjoining Mr. J. J. Kirby Lot. There were no dissenting votes.

Clerk was instructed to see Mr. Logan and let him direct him as to exact wording to be used in Deed.

- 2. Clerk presented replies from Clerks at Park City, Cave City, and Horse Cave, from his letters to them regarding types of licenses and amount charged Jewel Tea Company and Standard Coffee Company and like concerns. The Board then set charges against any such concern at \$20.00 per year (Peddler's License).
- 3. Carter Insurance Agency Occupation License Fee is hereby amended to read \$20.00 per year instead of \$5.00 as previously set at last meeting of the Board. Change made due to fact that Mr. E. W. Carter is, from March 1, 1954, on in the Insurance Business full time, not part time as previously operated.
- 4. A discussion of what has been done and what is to be done at the Cemetary. Clerk reported that Marshall Parrish began work on Monday, March 1, 1954, and had cut two trees and was working on others.
- 5. A discussion of the street situation Possible ways of getting property owners to share 50/50 in construction of new streets, etc.
- 6. A discussion of the Court Report from Clerk on fines collected in January and February and discussion of Juvinile speedsters, etc. Clerk was directed to write Mr. Charlie Renfro, Oakland, Ky., and Rev. G. O. Hoover, Smiths Grove, Ky., regarding the giving of tickets to them by the Town Marshal. Request that Mr. Renfro and Rev. Hoover come in and talk it over with Judge John H. Lowe.
  - 7. Fog nozzle for Fire Truck.

Upon a motion of Mr. Tarter seconded by Mrs. Crump, the Board agreed to purchase a bronze fog nozzle for the fire truck for a price of around \$40.00 from the Eureka Fire Hose Company, Nashville, Tenn. There were no dissenting votes since it is felt that such a nozzle is needed to help clear smoke in burning buildings.
