The regular meeting of the Board of Trustees of the City of Smiths Grove was held Tuesday, March 27, 1979 at the fire station. Those present were Leland Anderson, Robert Appling, Charles Cowles, and Paul Proffitt. The meeting was preceded by the Proposed Revenue Sharing Budget Hearing.

Mr. Appling Called the meeting to order. The reading of the minutes was dispensed with as copies of the minutes were distributed to Board members before the meeting. They were approved. The Treasurer's report was given. (attached)

Mr. Robert Alexander appeared before the Board. Two tractor-trailer rigs are parking near his home. The motor on the refrigerator truck is being left on all night. Sometimes the alley is blocked. According to City ordinances, the truck can be ticketed for blocking the alley or parking facing the wrong way. It was decided that Mr. Cowles would ask Mr. Watt to request they not park in this manner.

Committee Reports were called for.

Water: Mr. Appling read the financial report. The pit is still in need of being cleaned out. Ray Smith was supposed to clean it out, but it was felt he had not done enough to be paid for. Mr. Cowles moved, Mr. Anderson seconded that Mr. Smith be written a letter stating that until the work was completed the Water Dept would not pay him. Motion carried.

Police: Everything is O.K.

FIRE: Mr. Anderson reported that the truck wouldn't start again, and the muffler is bad. Mr. Appling moved, Mr. Cowles seconded that Mr. Anderson take the truck and repair the muffler, check the battery and any other needed repairs. Motion carried.

Streets: Mr. Proffitt reported some rock has been put around town. Cemetery: O. K.

Old Business

The Municipal Aid project for the current year was discussed. Mr. Proffitt will have a list of streets at the next meeting in order to make a final decision.

Mr. Ralph Anderson reported on the Community Development Program. He presented the Affirmative Action Plan that H.U.D. requested. (attached) Mr. Appling moved, Mr. Cowles seconded that the City adopt this in place of the Affirmative Action Plan the City adopted last November. Motion carried. A report will have to be made annually as to the City's progress under this plan.

Mr. Anderson also reported that the additional \$66,306 for this year was approved. It appears that our Grant request for 1979 was not considered since nothing has been heard from it at this time. The funded projects are to be announced on April 2, 1979.

Treh Par

Mr. Anderson presented a Fair Housing Ordinance to the Board. He explained that this deals entirely with commercially sold real estate. It would only bring enforcement of the policy to a local level. The City would be responsible for enforcing national policy rather than the federal district court. It was decided to table this question until the full Board was present.

Sue Edwards presented the financial statement for the C.D. Funds. Mr. Proffitt moved Mr. Leland Anderson seconded, to pay these bills. Motion carried (attached)

The clerk presented two Building Permits. Mr. Proffitt moved, Mr. Anderson seconded that a building permit be issued to Mr. Clarence Watt for the construction of a garage. The Board decided to turn down Mr. Billy Carroll's application because his lot was only 17,000 sq. ft. and not the 20,000 sq. ft. required by City Ordinance. It was also decided that they could not extend the City street to run in front of their lot, due to the expense involved.

Mr. Cowles moved, Mr. Proffitt seconded to accept the City Budget for 1979. (attached)

The meeting was adjourned.
