May 20, 1996 - Smiths Grove City Commission meeting

1996-1997 proposed use hearing for Municipal Aid road Funds, LGEAF funds and General Fund income and expenditures.

Mayor Gilley called the hearing for MA and LGEAF to order, asking the commission if they had any suggestions for the use of these funds. He explained that according the clerks projections, there would be a total of \$21,385 at the end of FY 96-97 for use on roads or sidewalks. Comm. Lacy said that he felt perhaps Hedge and Beeler Street should be given some consideration for repaving when funds become available. Mayor Gilley said these two streets had been resurfaced at the end of the city sewer project. Comm. Lacy was aware of this but felt they were wavy and in some places rough. The clerk recorded this suggestion on the proposed use form. Mayor Gilley said the city really needed sidewalks throughout, especially over by the school, but there just were never enough funds available for this purpose. The Mayor called for other suggestions or comments regarding the use of these funds. There were none. The Mayor then presented the proposed use hearing of the 1996-1997 general fund budget. The commission had no changes or suggestions to the proposed uses the clerk had drafted for their consideration. With no further comments Mayor Gilley declared these hearings closed.
