

The regular meeting of the City Commission of Smiths Grove was held May 25, 1981, at 7:00 P.M. in City Hall. Mr. Wolff moved, Mr. Walker seconded the minutes be approved as printed. Motion carried. Mr. Wolff moved, Mr. Crousore seconded the Treasurer's Report be approved as printed. Motion carried. (attached)

Budget

Mr. Walker stated that some stipulation should be made for the Community Center. Mayor Wolff explained that the only place there was any cushion in the budget was in the streets. A general discussion of roof estimates and remodeling costs ensued. It was also suggested Mr. Walker might contact Bob Dickens of the Mammoth Cave Job Corp Center. Mr. Walker moved, Mr. Pearson seconded, the budget be amended and \$3,000.00 of Revenue Sharing be moved from the Street Department and put in a separate department called Community Center. Vote: Walker-yes, Pearson-yes, Crousore-yes, Wolff-no. Motion carried. The amended budget was then presented for First Reading.

Community Development

Mr.-Wolff moved, Mr. Pearson seconded the Community Development Financial Statement be approved. Motion carried. (attached)

Someone was present asking about Rehabbing Millie Boards home. She would not give her name. This will be looked into.

Mr. Lawrence Clayton wanted to know about the lot on Hedge Street. The Commission had already taken action on that but the deed has not been drawn up.

Bids on Street work

Mayor Wolff explained he had been obtaining samples of other bids that cities have let. He further explained that when hiring outside labor the city must fill out federal and state wage rates. The bids can be advertised as soon as all those forms come back.

Cable T.V.

Mayor Wolff explained that the same procedure the City of Bowling Green went through would apply for Smiths Grove. An Ordinance establishing a cable T.V. franchise has been drawn and must have a first and second reading. It is modeled after the Bowling Green-Warren Co. Ordinance. A Hearing is scheduled for June 9, 1981. Storer is interested in the franchise. Mr. Wolf has been working with Mr. Wayne Priest on the Ordinance. A \$250.00 filing fee by every company who wants to file is required. The successful bidder will reimburse the City for any publishing or legal fees above filing fees. The City will have one free hook-up without charge. The special meeting is called for June 9, 1981, at 7:00 P.M. in City Hall for the first reading of the Ordinance. Storer is operational now, offering 35 channels. The city is bidding 20.

Building Permit

A building permit application for Shirley Martin was presented. It is a one family residence to be located on Wayne Street. Mr. Wolff moved, Mr. Walker seconded its acceptance. Motion carried.

Miscellaneous

Mr. Wolff announced the Crime Prevention Seminar, to be held Tuesday, May 26, at 7:00 P.M. at the Lions Club Bldg. Mr. Bernie Cox from the B.G. Police force will present the program.

The Fire Dept. and Street signs are in.

Mr. Walker moved, Mr. Pearson seconded the meeting be adjourned.
