Minutes of the meeting of the Board of Trustees, City of Smiths Grove, Tuesday, November 1, 1955.

The Board as usual met in the Director's Room of the Deposit Bank and all members of the Board were present.

After being called to order the following matters were taken up:-

- l. The Clerk presented a petition from the residents of Stock Street requesting that the name of their street to Laurel Street. Upon a motion of Mr. Denton, seconded by Mrs. Stone the Board voted to change the name of said street since all residents and property holders on that street had signed. Clerk is directed to notify those people of the official change.
- 2. The matter of the triangles at the Northwest entrance to the Cemetery for which the Board had granted permission to the Woman's Club and the Momemaker's Club to plant flower beds was discussed at length since Dr. J. B. Helm had presented deeds showing that the previous Board had deeded same to him. Mr. Tarter stated that he was not in favor of letting him have them since he did not pay for them and the deeds which he has are not correct. He called for a vote as to whether to let the matter stand as it is or whether to go to court if necessary to reclaim them. After further discussion the Board decided that in view of the fact that Court costs would be tremendous and that their term was nearly over they would just let the matter rest neither confirming Dr. Helm's right to title nor denying it. The Clerk was directed to refund the Smiths Grove Homemaker's \$3.50 for amount spent for labor in digging up triangle. The check is to be sent to Mrs. Nell Madison.
- 3. The Clerk was directed to write Asphalt Products Company at Nashville, Tennessee, for confirmation on their oil bill.
- 4. The clerk presented a letter which Mr. Meredith had from the Nashville firm had recommending size of letters for markers and the Board recommended 3" lettering for Posts.
- 5. Judge Lowe presented a problem which he and the Town Marshall had been having over fines. Judge Lowe stated that two men which were on the books as being fined (Kendle Cannon and Jewel Furlong) had not been fined yet the Marshall was claiming that they had been. The Clerk and Judge presented the following accounts which the Marshal owes the City:
