Minutes of the meeting of the Board of Trustees, Thursday, November 14, 1963.

The Board met at the American National Bank and Trust Company with one member, Trustee Harold McGuffey, absent.

Minutes of the previous meeting were read and approved.

1. Judge Keener was present. He reported he had a warrant for one person for reckless driving, but no witnesses would appear. He told the boy if he were brought before him again during the next year for the same charge, the fine would be doubled.
2. Clerk reported the City fund as \$3898.84 and the Fire Truck Fund as \$57.13.
3. The Cemetery account now stands at \$1830.02 with the Hardy Account at \$300.
4. Marshall Denton was not present.
5. Street markers were not discussed.
6. The Zoning Committee had no report.
7. The information on the hearing from the increase in water rates still has not been located.
8. The repair work on Second Street and a small amount on 4th street has been completed. Total cost cannot be ascertained until bill is received for the oil which was used.
9. There was no further report on the vaporet lot near the Hardy Funeral Home.
10. Chariman Jordan reported the gravel on Fourth Street between Cave and Hedgerow has been applied and the members commented this was a great improvement.
11. The new members of the Board of Trustees will be: Joe Lowe, Bill Powell, Carroll Bevarly, Frank Jordan and Carl Ferguson. These five received the most votes in the November election. It was suggested that Mr. Bevarly and Mr. Ferguson attend the December meeting of the Board.
12. Clerk was asked to send unloading notices to Shipley DoNut, Steve Clark, Crabtree Sausage and Lindsey Tire Service.
13. Chairman Jordan presented a bill for \$1.50 for removing dead dogs from Main Street. Also a bill for \$15 from Francis and Potter for the water option contract. Clerk was authorized to pay these bills.
14. Judge Keener has been serving since the first of Aggust and has received no pay as the Board had reached no decision on the amount. Trustee Lowe made a motion that this salary be set at \$25 a month with the Judge not retaining any hearing fees. Trustee Powell seconded the motion. There were no dissenting votes. Clerk was authorized to pay him.
15. During the last month, a false fire alarm was sounded. It was the opinion of some of the citizens that they had enough leads to notify the Fire Marshall.

16. Clerk was asked to write letters to all ~~persons~~ persons who have not paid their taxes advising them that unless they were paid by December 1, legal action would be taken.

17. Clerk was asked to write Virgil Wilson a letter concerning the \$57 note which he signed for Bobby Wilson.

18. Clerk was asked to notify the State Police that we now have a Police Judge.

There being no further business, the meeting adjourned until the next meeting to be held in December.
