Community Development

Glasgow Paving had finished Hedge Street and the bill was \$2,362.60. Mr. Walker moved, Mr. Jackson seconded the City pay the \$162.20 above the \$2,200.00 allocated for this project. Motion carried.

Street Department

The alley down by the Forestry Dept. needs some rock. It was suggested that the County might do this because of the Forestry Dept.

Zoning Ordinance

Mayor Wolff had nothing specific to report. He has to meet with Mr. Matheny again.

Building Permit

James Nalley applied for one for remodeling of his house on Hedge Street. Mr. Jackson moved, Mr. Pearson seconded, the Building Permit be approved conditional on approval of the Health Dept. for sanitary facilities Motion carried.

Miscellaneous

A. Mr. Pearson moved, Mr. Jackson seconded, Mr. James Hendricks be given authority to clean up the alley near the mill and use it as long as it isn't blocked. Motion carried.

B. Staggered Terms

The 1980 legislature provided for staggered terms for Commissioners. Mayor Wolff tried to have it put on the ballot for the November election, and was informed that it couldn't be put on because it was the first time the Commissioners would be elected. He asked they check into this further, but by the time the information came back it was to late to put it on the ballot.

C. Farmer's_Home & Imp. Inc. had a bill for \$239.35 for which money had not been budgeted. Mr. Pearson moved, Mr. Jackson seconded it be paid. Motion carried. (Community Center Roof) D. Christmas Bonus

Mr. Pearson moved, Mr. Walker seconded the City employees be paid a \$25.00 Christmas Bonus. Motion carried.
