Mayor Gilley called the meeting to order with all commissioners in attendance.

He feels that the insurance companies issue payment for all persons with a Smiths Grove address, rather than just those in the city limits of Smiths Grove and sometime in the future these funds will have to be returned. The Auditor called for questions regarding the audit. There were none to be heard. Mayor Gilley thanked Mrs. Gilbert for taking the time to review the audit with the commission.
