Minutes of the meeting of the Board of Trustees, Wednesday, October 18, 1961.

The Board met a 7 PM in the American National Bank and Trust Company with one member, Trustee Joe Lowe absent.

1. Minutes of the previous meeting were read and approved.
2. Marshall Britt was unable to attend the meeting and did not send any report.
3. Since we have no police judge, there was no report.
4. The Industrial Development Board had no further report.
5. There is nothing new concerning the Browning Oil Company Buildings on Main Street.
6. Street markers were not discussed.
6. Clerk reported that Ford Thomas has paid \$15.72 for his share of the blacktopping used in patching the streets.
7. A total of nine names were submitted for the November election, the present board and Orin Jackson, Allie Long, B. J. Miller and Carroll Bevarly.
8. Clerk was asked to contact Joe Frank Burnett regarding the junk cars belonging to Cleveland Boards.
9. Chairman Jordan reported that the F. B. Hardy account for the cemetery has been reduced to \$250.
10. The volunteer firemen have flushed all the plugs and all are in working condition.
11. Chairman Jordan reported he had contacted Ford Thomas to turn off the water at the Cemetery from October to May. Clerk was asked to write a follow-up on this.
12. Clerk reported that the Office of the Attorney General has replied that any officer of the city must be a legal resident of the City for at least one year preceeding his election or appointment.
13. The street light near the Allie Long property has been installed.
14. Blacktopping has been completed on Sun Street, First Street and Cave Street.
15. Chairman Jordan reported the activities of some younger boys in vandalism acts has improved.
16. A general discussion was held on police portection for Halloween. Chairman Jordan volunteered to contact the Sheirff's department. Chairman McGuffey volunteered to contact the State Police. Trustee Madison made a motion that Chairman Jordan contact Roland James to be a special deputy.

for Halloween night. Trustee Powell seconded the motion. There were no dissenting votes.

17. Chairman Jordan said Mrs. Cassady had been unable to locate the police records but they were continuing to search for them.

18. Chairman Jordan reported a profit of \$210 from the fish fry. These proceeds are to be used for the fire truck fund.

19. There has been no report or response to the application for State Aid for the fire truck. This application was filed in June. Clerk was asked to contact Allie Long and Tommy Melton to consult with Troy Truck concerning this situation.

20. Trustee McGuffey made a motion that no one over 12 years of age wear a mask on Halloween. Trustee Powell seconded the motion. There were no dissenting votes. Clerk was asked to contact the Park City Daily News regarding publicity of this resolution. Chairman Jordan volunteered to contact Mr. Renick concerning this announcement at the school.

There being no further business, the meeting adjourned until the next regularly scheduled meeting the first Wednesday in November, 1961.
