McGuffey wondered if the commission should proceed with a vote or wait to contact the Prewetts to see if they wanted the light. Mayor Gilley said it wasn't necessary to contact the Prewetts. Mr. Laws agreed to talk with WRECC to see what the cost is to install a light. Comm. McGuffey motioned to table this issue until the next meeting until all of the facts and figures were presented.

5. Installation of 4" water line on Webb Ave. and a fire hydrant there and on Lawson St.

The clerk had given the commission the figures given to her from Warren Co. Water Dist. regarding these installations. The Water Co. said it would not exceed \$6,000.00. Comm. McGuffey presented a motion to proceed as soon as possible with these installations, seconded by Comm. Stiffey. The clerk agreed to contact the water company to get them to proceed as soon as possible. Roll call and vote - Belcher yes, Gilley yes, Crisp yes, Stiffey yes, McGuffey yes.
