Public hearing to receive comments from the public regarding the 4% allowed tax rate on the 1992 tax rate of personal and real property. Mayor Gilley called for comments or discussions from those in attendance. With none to be heard, Mayor Gilley declared the hearing closed.

1. Minutes of the previous meeting

Mayor Gilley called for comments or discussion on these minutes. With none to be heard, Comma Lacy presented a motion the minutes be accepted as written, seconded by Comma Martin. roll call and vote - Belcher yes, gilley yes, Martin yes, Lacy yes.

2. Minutes of the two special called meetings

Mayor Gilley explained the purpose of these two special called meetings were to hear the readings of three ordinances pertinent to the sewer grant. Comma Belcher floored a motion to accept the minutes of the two special called meetings, seconded by Comma Lacy. Roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes.

3. Treasurer's report

Mayor Gilley called for additions or corrections to this report. With none to be heard, Comm. Belcher presented a motion the report be accepted as printed, seconded by Comm. Martin. roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes.

4. First reading Ordinance #92-4 220.111-1992 property tax rate

The Mayor explained the rate for 1992 would be .-179¢-per \$100 assessed valuation on real property. Comma Belcher presented a motion this ordinance be accepted for a second reading, seconded by Comma Lacy. Roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes.

5. First reading Ordinance #92-5 220.112 - 1992 tax rate for tangible property

The Mayor explained this was the first year the city had adopted a different tax rate for personal property. The clerk said in order to keep the cash flow consistent, this rate of .209¢ per \$100 assessment was necessary. Comma Martin presented a motion this ordinance be accepted for a second reading, seconded by Comma Belcher. roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes.

6. First reading Ordinance #92-6 220.113-1993 vehicle tax rate

This rate of 30¢ was the same as in the past two years. Comm. Lacy presented a motion this ordinance be accepted for a second reading, seconded by Comm. Belcher. roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes.

7. First reading Ordinance #92-1 910.2 approving update of 1990 Comprehensive Plan

Comm. Belcher presented a motion this ordinance be accepted for a second reading, seconded by Comma Martin. Roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes.

8. Opening of sealed bid for police cruiser

The commission had received one rebid for this car. It was from Greenwood Ford in the amount of \$13,848.00 (copy attached), for a 1992 Ford Crown Victoria police package vehicle. Since this figure was within the \$15,000 grant the city had received, Comm. Belcher presented a motion the bid of \$13,848 from Greenwood Ford be accepted, Seconded by Comm. Lacy. Roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes. The

commission instructed the clerk to proceed with the required papers to fulfill the grant requirements. She agreed to do so.

9. Other

Mr. & Mrs. Robert Owens were in attendance and wished to address to commission regarding the opening of a Day Care Center at 107 Laurel. They had obtained the approval signature of the surrounding neighbor, (copy attached). Mayor Gilley said the commission would now turn this matter over to the Smiths Grove Board of Adjustments for their approval of the zoning requirements involved. Commissioner Lacy said that the upper end of Webb Ave. and Ridgecrest had been chipped and sealed by the county and as yet the city had not received a bill for the work.

Quarterly financial report-Smiths Grove Cemetery

The clerk explained this report was not a part of the agenda because it had been late in getting finished. Mayor Gilley called for questions or corrections to this report. With none to be heard, Comm. Martin presented a motion the report be accepted as printed, seconded by Comm. Belcher. Roll call and vote - Belcher yes, Gilley yes, Martin yes, Lacy yes.
