7. Trustee Blackwell reported he had received a request for a street light between the Baptist and Christian Churches. It was the concensus of the Board that this problem could be solved with the installation of a security light by the Baptist Church. 8. Trustee Powell reported that he is delighted with the work which has been done regarding the leask under the RR track. This work was accomplished at a much lower price than had been expected. Highway #101 is still to be repaired with the 2" black top and they will only accept hot mix. He is hoping to get this done within a few days.

9. The drain in front of the Carl ^Netherton property was discussed. ¹t was decided this was State buisiness and Bill Powell is to contact David Watkins regarding this situation.

10. Judge Blud said the water bill collections are about the same. The same ones are still behind.

11. Trustee Hill reported our ordinance reads that the penalty on the water bills will start the 14th while the cards read the 10th. Trustee Hill made a motion that the ordinance be amended to read the penalty will take effect **WEXXER** on the 10th of the month. Trustee Blackwell seconded the motion.
