### CITY OF SMITHS GROVE

A Resolution authorizing Mayor James Gilley, on behalf of Smiths Grove City Commission, to enter into an Interlocal Cooperation Agreement, pursuant to KRS 65.210 et. seq., KRS 67.080 (e), KRS 83A.010 (8), KRS 83A.130,KRS83A.140, KRS 83A.150, and Todd County Fiscal Court v. Frey, Kentucky, 285 S.W. 2d 499, 500 (1956), with the Allen, Barren, Butler, Edmonson, Hart, Logan, Metcalfe, Monroe, Simpson and Warren Fiscal Courts, and the incorporated cities within the boundaries of the Barren River Service Delivery Area, for the purpose of establishing the Barren River CONSORTIUM to administer training programs in accordance with the Workforce Investment Act.

WHEREAS, the Workforce Investment Act, enacted by the Congress of the United States, provides for grants of federal funds, to State and local governments for programs designed to increase employment and earning, increase educational and occupational skills, and decrease welfare dependency, thereby improving the quality of the workforce and enhancing the productivity and the competitiveness of the Nation;

WHEREAS, the Smiths Grove City Commission recognizes that local job training programs cannot be completely effective or implemented without intergovernmental coordination for the reasons that such programs and their implementation cross governmental, departmental and agency lines at the various levels of government; and

WHEREAS, the City Commission desires to enter into an Interlocal Cooperation Agreement, pursuant to KRS 65.210 et. seq., KRS 67.080(e), KRS 83A.130,KRS 83A.140, KRS 83A.150, and Todd County Fiscal Court v. Frey, Kentucky, 285 S.W. 2d 499, 500 (1956), with the Allen, Barren, Butler, Edmonson, Hart, Logan, Metcalfe, Monroe, Simpson and Warren County Fiscal Courts, and the incorporated cities within the boundaries of the Barren River Service Delivery Area, for the above purposes:

NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF SMITHS GROVE:

Section 1. That the Mayor, James Gilley, is hereby authorized to enter into and execute an Interlocal Cooperation Agreement, pursuant to KRS 65.210 et. seq., KRS 67.080(e), KRS 83A.010(8), KRS 83A.130, KRS 83A.140, KRS 83A.150, and Todd County Fiscal Court v. Frey, Kentucky, 285 S.W. 2d 499, 500 (1956), with the Allen, Barren, Butler, Edmonson, Hart, Logan, Metcalfe, Monroe, Simpson and Warren County Fiscal Court, and the incorporated cities within the boundaries of the Barren River Service Delivery Area, a copy of which is attached hereto and made a part hereof, for the purpose of establishing the Barren River Consortium to implement training programs under the Workforce Investment Act.

### **WORKFORCE INVESTMENT ACT OF 1998**

#### RESOLUTION

WHEREAS, the Barren River Area Development District has served as the Administrative Entity and Grant Recipient of the Job Training Partnership Act Program for the Barren River Private Industry Council (PIC), comprising the counties of Logan, Simpson, Butler, Warren, Edmonson, Hart, Barren, Allen, Metcalfe and Monroe;

WHEREAS, the Barren River PIC has successfully demonstrated its ability to implement and maintain the effective delivery of employment and training programs to the area's economically disadvantaged individuals; and

WHEREAS, the Workforce Investment Act of 1998, enacted by the Congress of the United States, provides federal funds to State and local governments to provide workforce investment activities through statewide and local workforce investment systems that increase the employment, retention, and earnings of participants, and increase occupational skills attainment by participants, and, as a result, improve the quality of the workforce, reduce welfare dependency, and enhance the productivity and competitiveness of the Nation; and

WHEREAS, the Governor of the Commonwealth of Kentucky, pursuant to Section 116 (a) (3)(A)(i)(ii) of the Workforce Investment Act of 1998, has the authority to designate the geopraphic area encompassing the above named Kentucky counties as a Workforce Investment Area; and

WHEREAS, the Barren River Area Development District Board of Directors, created by KRS 147A.060, representing Logan, Simpson, Butler, Warren, Edmonson, Hart, Barren, Allen, Metcalfe and Monroe desire to join with the incorporated Cities within the boundaries, to form a Workforce Investment Area, for the above purposes; and

WHEREAS, KRS 147A.080 gives power and authority to the Barren River Area Development District Board of Directors to accept, receive, and administer loans, grants, or other funds or gifts from public and private agencies including the Commonwealth and the federal government for the purpose of carrying out the functions of the district; and

WHEREAS, KRS 147A.080 gives authority to the Board of Directors to enter into interlocal agreements,

NOW, THEREFORE BE IT RESOLVED, that the Barren River Area Development District Board of Directors urge the local governments of each County and Incorporated Municipality

within Logan, Simpson, Butler, Warren, Edmonson, Hart, Barren, Allen, Metcalfe and Monroe to request the Governor of the Commonwealth of Kentucky to establish a Local Workforce Investment Area comprised of the governmental entities listed including the Incorporated Cities therein, and that the Governor authorize the Barren River Area Development District to be the administrative entity and the subrecipient/grant recipient and authorize the Barren River PIC to be designated as the Barren River Consortium to serve as the Local Workforce Board for this Local Workforce Investment Area, and

**BE IT FURTHER RESOLVED** by the local elected officials of the ten county region known as the Barren River Area Development District, that the Chairman of the Barren River Area Development District Board of Directors be the authorized representative of the local elected officials to act as the Chief Elected Official within the BRADD and authorized to sign the Interlocal Cooperative Act establishing the Barren River Consortium to comply with the requirements of the Workforce Investment Act of 1998.
