Minutes of the meeting of the Board of Trustees, Tuesday, September 1, 1959. The Board met at 7:30 P.M. in the Director's Room of the American National Bank and Trust Company with one member, Trustee Anderson absent. The following business was transacted: Minutes of the previous meeting were read and approved. 2. Police Report - Mr. Cassady had collected \$25 on an old fine from Buddy Vance and reported that Winford Faulkner had been fined \$50 for flourishing a deadly weapon. 3. Clerk presented a bill from Asphalt Products, Co., Inc. in the amount of \$511.13 for oil and a bill from McClellan Stone Company in the amount of 575.46 for rock which was used in resurfacing the streets. Trustee Denton made a motion that these bills be paid. Trustee Thomas seconded the motion. There were no dissenting votes.

- Trustee Thomas reported the door for the fire station had come but some springs were missing. This work should be completed within a short ehile. Mr. Smith reported a new thermostat would be installed at the fire station.
- 5. Clerk reported that Mr. Rex Logan had interpreted a letter from the Atoorned General to the effect that the town could be sued.
- 6. Trustee Jordan reported that the hole in fromtof the L. Carl Rasdall dwelling had been taken care of.
- 7. Mr. Cassady said he would see about cleaning some drains.
- 8. Mr. Cassady presented the problem of some blacktop which is needed in front of the fires station. Trustee Thomas made a motion that this be done. Trustee Denton seconded the motion. There were no dissenting votes. Mr. Cassady is to supervise this work.
- 9. Trustee Thomas made a motion that if at least 50% of the property owners on a street desire the street to be resurfaced and the town is agreeable to the work, then the property of those not willing to pay their pro rata share will be assessed for the amount due. Denton seconded the motion. There were no dissenting votes.
- 10. The annexing of outlying districts was discussed. Mr. Smith is to contact Oval Motley to see if he has on record a map of the town so the correct boundaries can be established. This question is to be discussed again at the next meeting.
- 11. Clerk reported the Chairman had written letters to Bert Combs and also the State Chamber of Commerce regarding a factory for Smiths Brove.
- 12. The Board members did not have enough prospective names for the next election of Board Members. Chairman Smith asked that names be given him within the next week so the ballots can be printed.
- 13. Chairman Smith reported the jail needed cleaning and Mr. Cassady said he would see to this.

14. Trustee Jordan made a motion that Ford Thomas be paid \$12 for the no dumping and no parking signs which he had painted. Trustee Denton seconded the motion. There were no dissenting votes.

There being no further business, the meeting was adjourned until the next regularly scheduled meeting the first Tuesday in September.
