Mr. Proffitt moved, Mr. Cowles seconded the acquisition of a permanent easement from the William Marr's for \$1,000.00 in order to put in the septic tank needed for Lee Amos Pearson's property. Motion carried.

A Public Hearing was held on Monday, September 10, 1979, at 7:00 P. M. at the County Fire Station in Smiths Grove, Kentucky, for the purpose of revising the Housing Assistance Plan in the 1978 Community Development Application.

The origional goals were set up to include fifteen home owners and fifteen renters. As the program got underway it was clear the initial goals based on a survey done by local officals were off somewhat. The actual program contains twenty-one home owners and nine renters.

The additional \$66,000.00 recieved has enabled more rehabilitation.

H.U.D. suggested the origional goals be revised. If the City were to apply at a later date there could be no criticism that the goals were not met in the first plan.
