City Commission meeting - September 26, 1983 -7:00 p.m. City Hall

The meeting was called to order by Mayor Milliken at 7:00 p.m. Comm. in attendance were Comm. Garmon, Comm. Pearson, Comm. Stiffey and Comm. Benson. Numerous interested citizens were also in. attendance.

A motion by Comm. Benson to dispense with the reading of the minutes of the previous meeting was heard, seconded by Comm. Pearson. Roll call and vote - Garmon yes, Pearson yes, Milliken yes, Stiffey yes, Benson yes.

The Mayor distributed the Treasurer's re ort for the Commissioners to review.

The Mayor announced on Se t. 23 a special called commission meeting was held for the purpose of replacing Comm. Leland Anderson who had passed away. This meeting deemed necessary under K S83A.040. He said Jennings Garmon had been unanimously chosen to fill the vacancy and had been duly sworn in as a City Commissioner by Squire Richard Kirby.

Mayor Milliken told those in attendance; Bob Turner of Turner Industries had contacted him to invite all interested citizens and commissioners to an informal gathering at the Kane mfg. building Thurs. Sept. 29th at 7:30 p.m. The Mayor explained, since Kane mfg. Co. had closed, he and many others wanted to see that another business used this building, both to offer employment to our citizens, and so that the building wouldn't stand vacant and become an eyesore for the community. He further explained, Mr. Turner was negotiating the purchase of this building, and one of the reasons he wanted to meet with the commissioners and citizens was to hear their views on what they would like as a business and to get to know them. Mayor Milliken urged everyone to attend if at all possible.

Mayor Milliken introduced Mr. John Mathaney from the Warren Co. Planning Comm. and Mr. Horace Schrader. Mr. Schrader spoke briefly on the purpose of the Future Directions Committee. He said they were now in the process of conducting a survey, which should be completed in about three months, to determine the areas around Bowling Green and Warren County which were most needy of their services. Mayor Milliken ask if there were any questions or comments to be directed to either Mr. Schrader of Mr. Mathaney There were none. The Mayor thanked them for taking the time to come to the meeting.

The Mayor explained, through the BRADD offices; government funds had been made available in the form of grants for the purpose of city beautification. He applied for; and received one such grant. The city has received \$5,207.68 for the purpose of labor and \$2,800.00 for plant material. He has now received an additional \$600.00 for plant material. He wanted the citizens to know the beautification which was occurring within the city was through this grant and not from tax dollars.

### Smiths Grove-Warren County Library tax rate

The Mayor explained the statute, KRS 173.360, and the Attorney General's opinion 68-320, (copy attached), which deals with libraries for sixth class cities. A lengthy discussion with

Benson that presented a motion the library tax rate be set at \$.06 per \$100 assessment, seconded by Comm. Pearson.- Roll call and vote.- Benson yes, Stiffey abstain, Milliken yes, Pearson yes, Garmon yes. Motion carries 4-1.

The Mayor ask the commissioners if they had had time to review the treasurer's report. With no questions or additions to be heard, Comm. Benson presented a motion the report be accepted as printed, seconded by Comm. Pearson. Roll call and vote - Benson yes, Stiffey yes, Milliken yes, Pearson yes, Garmon yes.

# Wallace Cole building permit

A building permit for Wallace Cole to erect a single family dwelling at the corner of Highland and Hunt Road was again presented for the commission's approval. After a brief discussion, a motion to issue the permit was made by Comm. Stiffey,

A building permit for High Quality Inc., to erect a single family dwelling on lot 10 in the Rice Addition was presented for consideration. A motion was heard from Comm. Pearson, seconded by Comm. Garmon to issue this permit. Roll call and vote - Benson yes, Stiffey yes, Milliken yes, Pearson yes, Garmon yes.

# Thomas Webb building permits - Lot #25 & #26-Webb Circle

Two building permits for Thomas Webb's houses on Webb Circle were presented for the commission's consideration. A motion to issue these permits was made by~Comm. Garmon, seconded by Comm. Stiffey. Roll call and vote-Benson yes, Stiffey yes; Milliken yes, Pearson yes, Garmon yes.

# Street repairs - Lawson & Kirby Streets

Comm., Pearson presented estimates from Scotty's and Medusa Aggregate for gravel to repair Lawson and Kirby St. in the amount of \$90.00 to \$100.00. Comm. Stiffey presented a motion to purchase this gravel, seconded by Comm. Garmon. Roll call and vote - Benson yes, Stiffey yes, Milliken yes, Pearson yes, Garmon yes.

Mayor Milliken said Mr. Cole who lives on Fourth St. had called and said there was a large crack in the street in front of his house. Mayor Milliken said he would write a letter to Scotty's and ask them to rectify this and the needed repairs on Vincent St.
